

# OFFICIAL CALL

## *Mass Meeting of Republican Party of Norfolk of the Republican Party of Virginia*

As Chairman of the Republican Party of Norfolk of the Republican Party, and pursuant to the Plan of Organization and as recommended and directed by the Committee, I, Thomas Cherry, do hereby issue this call for a Mass Meeting to be held at Norfolk Masonic Temple, 7001 Granby Street, Norfolk VA 23505 starting at 7:00 pm local time on April 19, 2018 for the following purposes:

- a) Electing a Unit Chairman.
- b) Electing members of the Unit Committee, the Republican Party of Norfolk.
- c) Electing up to 365 Delegates and an equal number of Alternates to the 2nd District Convention, to be held on May 19, 2018 at the Norfolk Masonic Temple, 7001 Granby Street, Norfolk VA 23505 beginning at 10:00 am for the purposes of electing a District Chairman. Each unit is entitled to one (1) Delegate Vote per 250 Republican votes for Governor and President at their last election, so that the Republican Party of Norfolk is entitled to 73 Delegate Votes.
- d) Electing up to 335 Delegates and an equal number of Alternates to the 3rd District Convention, to be held on May 5, 2018 at Smithfield Middle School, 1475 Turner Drive, Smithfield, VA 23430 convening at 11:00 am for the purposes of electing a District Chairman. Each unit is entitled to one (1) Delegate Vote per 250 Republican votes for Governor and President at their last election, so that the Republican Party of Norfolk is entitled to 67 Delegate Votes;

### Qualifications for Participation

All legal and qualified voters of City of Norfolk under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions or primaries encompassing their respective election districts.

Filing Requirements Pre-filing is required for the Mass Meeting no later than Thursday, April 10, 2018 at 5:00pm as a candidate for delegate. If running for Chairman of the Republican Party of Norfolk, a \$100.00 filing fee is required along with the same filing form by April 10, 2018 at 5:00pm to Chairman Tom Cherry, 1440 Cloncurry Rd Norfolk VA 23505. Postmarks do not govern. No nominations for the position of Chairman of the Republican Party of Norfolk can be made from the floor of the Mass Meeting.
