

**OFFICIAL CALL FOR A
PARTY CANVASS**

**25th House of Delegates Legislative District Republican Committee
of the Republican Party of Virginia**

As Chairman of the **25th House of Delegates Legislative District Republican Committee** of the Republican Party of Virginia (“Committee”), and pursuant to the State Party Plan of Organization, I Paul R. Comes, do hereby issue this call for a Party Canvass to be held at the following locations:

Augusta County

Augusta County Government Center: 18 Government Center Lane, Verona, Virginia, 24482

Precincts: Crimora, Dooms, Fishersville, Fort Defiance, New Hope, Verona, Weyers Cave, Wilson

Rockingham County

Bridgewater Town Office (Arey Assembly Hall): 201 Green Street, Bridgewater, Virginia 22812

Precincts: Port Republic, Grottoes, Massanetta Springs, Crossroads, West Bridgewater, Montezuma, Mt Crawford, North River, Ottobine, East Bridgewater

Albemarle County

Crozet Library: 2020 Library Ave, Crozet, VA 22932

Precincts: Brownsville, Crozet, East Ivy, Ivy Jack Jouett, Mechums River, Yellow Mountain

Starting at 10:00 AM local time and ending at 4:00 PM local time on April 27, 2019 for the purpose of Nominating a Republican candidate for the office of Delegate of the Virginia 25th District of the Virginia House of Delegates.

Qualifications for Participation

All legal and qualified voters of the 25th House of Delegates Legislative District under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions or primaries encompassing their respective election districts. Voters will be required to present a validly issued photographic identification as defined by the Virginia Department

of Elections and sign a written certification that they are in accord with the principles of the Republican Party as expressed in the Virginia Republican Creed and confirming their intent to support all of its nominees for public office in the ensuing election. No voter who refuses to present such identification or sign such certification will be permitted to vote.

Candidate Filing Requirements

1. File a written statement on the form attached hereto (“Official Prefiling Form”) mailed or in person to Paul R. Comes, Chairman, of the 25th House of Delegates Legislative District Republican Committee, 636 New Hope and Crimora Road, Fort Defiance, VA 24437, Which must be received by 5:00 PM local time on March 6, 2019. Postmarks shall not govern.
2. Pay the sum of \$1,000.00 by check, made out to the **25th House of Delegates Legislative District Republican Committee**, in person to Paul R. Comes, Chairman of the 25th House of Delegates Legislative District Republican Committee, at 636 New Hope and Crimora Road, Fort Defiance, VA 24437, which must be received not later than 5:00 PM local time on March 6, 2019. The failure of any person to fully and timely satisfy the aforesaid requirements shall preclude them from running for the nomination of Delegate. Postmarks shall not govern.

Registration Fee

There will be no registration fee for voters to participate in this Canvass.

Rules

1. Ballot order will be determined by lot.
2. The winner of a tie will be determined by lot.
3. There will be no write-in votes, absentee ballots or proxy votes allowed.
4. Polls will close at 4:00 PM sharp. Only those in line to vote at 4:00 PM will be allowed to vote.
5. Other rules, requirements and procedures deemed necessary for the orderly conduct of said Canvass adopted by the 25th House of Delegates Legislative District Republican Committee for said Canvass shall be deemed to have full force and effect as if set forth verbatim in this Call.

Approval/Publication/Revisions

The 25th House of Delegates Legislative District Republican Committee voted at a duly called meeting on January 23, 2019, to approve the terms of this Call, authorize the Chairman to make technical changes if required and to change the location of any Canvass site if any of the above chosen locations is not available, and to waive publication of this Call in a newspaper.
