



I, Sonya Murdock, Chairwoman of the Montgomery County GOP, and pursuant to the Plan of Organization and recommended by the Committee, do hereby issue this call for a Party Canvass (Firehouse Primary) to be held from 9:00am until 1:00pm (EST) on Saturday, May 4<sup>th</sup>, 2019, for the purpose of nominating a Republican candidate for Sheriff, Commonwealth's Attorney, County Treasurer, and Commissioner of Revenue, all for Montgomery County, VA . This call will also be for the purpose of nominating a Republican candidate for the following Montgomery County, VA Board of Supervisors Districts: B, E, F, and G.

#### Qualifications for Participation

All legal and qualified voters of Montgomery County under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions or primaries encompassing their respective election districts.

#### Filing Requirements

Candidates for the nomination or election at said canvass shall file a Candidate Filing Form by mail or in person, to Chair Sonya Murdock, 35 Wood Ridge Drive, Christiansburg, VA 24073, and must be received not later than 5:00pm EST on April 3, 2019. If not more than the number of persons to be elected shall file for each office, then such properly filed persons shall be declared nominated or elected as the case may be, and no canvass will be held for such purpose. There will be a \$500.00 non-refundable filing fee for candidates in county-wide races and \$440.00

non-refundable filing fee for candidates running for Board of Supervisors to participate in this canvass. This fee must be paid and submitted with the Candidate Filing Form by mail or in person, not later than 5:00pm EST on April 3, 2019, to Chair Sonya Murdock, 35 Wood Ridge Drive, Christiansburg, VA 24073. Actual receipt is required and postmarks do not govern receipt. #### Voting Locations

Qualified and legal voters of District E will be permitted to vote at either (but not both) the Montgomery County Government Center, or the Longshop-McCoy Fire Department. All other qualified and legal voters of Montgomery County will vote solely at the Montgomery County Government Center.
