Qualifications for Participation

All legal and qualified voters of Rockingham County Election District 4, under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin, or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally, or in writing, as may be required, their intent to support all of the nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meeting, party canvasses, conventions, or primaries encompassing their respective election districts.

Each person offering to vote shall present a non-expired photographic identification issued by the Commonwealth of Virginia, one of its political subdivisions, or the United States Government. No absentee voting or proxies will be permitted. There will be no registration fee to participate in this Mass Meeting.

Only legal and qualified voters of Rockingham County Election District 4 shall be eligible to participate. 4th District Precincts: Ottobine, Bridgewater East, Bridgewater West, Montezuma, Mount Crawford, North River

Filing Requirements

Candidates for the election at said Mass Meeting shall file a written statement of intent to run to Dan Cullers, 2300 Four Leaf Circle, Dayton, VA 22821, which must be received no later than 5:00 PM, March 29th, 2019. Postmarks shall not govern. The statement must be accompanied by a filing fee of \$300, payable to the Rockingham County Republican Committee. If only one candidate properly files by the deadline of 5:00 PM, March 29th, 2019, then said candidate shall be declared the Republican nominee and no mass meeting will be held.
