

**OFFICIAL CALL**  
**Party Canvass**  
**FREDERICK COUNTY REPUBLICAN COMMITTEE**  
**of the Republican Party of Virginia**

As Chairman of the Frederick County Republican Committee (“FCRC”) of the Republican Party of Virginia, and pursuant to the Plan of Organization and as recommended and directed by the Committee, I, Timothy Stowe, do hereby issue this call for a Party Canvass to be held at Greenwood Volunteer Fire and Rescue Company Event Center (behind fire hall), 809 Greenwood Road, Winchester, VA 22602 from 4:00 PM to 8:00 PM local time on Tuesday, April 30<sup>th</sup>, 2019 for the following purposes:

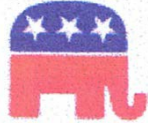
- a) Nominating a Republican candidate for the office of Frederick County Sheriff;
- b) Nominating a Republican candidate for the office of Frederick County Commonwealth Attorney;
- c) Nominating a Republican candidate for the office of Frederick County Treasurer;
- d) Nominating a Republican candidate for the office of Frederick County Commissioner of Revenue;
- e) Nominating a Republican candidate for the office of Frederick County Board of Supervisors, Back Creek District;
- f) Nominating a Republican candidate for the office of Frederick County Board of Supervisors, Gainesboro District;
- g) Nominating a Republican candidate for the office of Frederick County Board of Supervisors, Opequon District;
- h) Nominating a Republican candidate for the Chairman at Large of the Frederick County Board of Supervisors.

All candidates are to be voted for in the general election on November 5<sup>th</sup>, 2019.

**Qualifications for Participation**

All legal and qualified voters of Frederick County, under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party of Virginia and the Frederick County Republican Committee bylaws, and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its party canvasses encompassing their respective election districts.

A voter who, subsequent to making a statement of intent, publicly supports a candidate in opposition to a Republican nominee shall not be qualified for participation in party actions as defined in Article I for a period of four (4) years.



## **Balloting**

Balloting will begin at 4:00 PM and will end at 8:00 PM, except that anyone in the registration line at 8:00 PM may continue the registration process.

In order to receive a ballot, the voter must present a valid, non-expired photo identification issued by the Commonwealth of Virginia, one of its political subdivisions, or the United States government.

A statement of intent, properly completed and signed by the voter, must be submitted at the time of registration. No ballot will be given to any voter who has not signed and submitted this statement of intent.

No absentee voting, proxies, or provisional ballots are permitted.

Votes will be counted only for those candidates whose names appear on the official ballot. No write-in votes will be permitted. Any ballot with more than one candidate name marked for a office will be declared invalid.

## **Filing Requirements for Candidates**

Candidates for the nomination shall pay a filing fee of \$100.00 and submit a completed Candidate Filing Form no later than 5:00 PM on Thursday, March 21<sup>st</sup>, 2019, to Larry Ambrogi, 101 Armstrong Cir., Winchester, VA 22602. Forms must be received by the stated deadline. Postmarks do not govern.

If not more than the number of persons to be elected shall file for each office, then such properly filed persons shall be declared nominated or elected as the case may be, and no party canvass will be held for such purpose.

## **Pre-filing & Registration Fees for Party Canvass Participants**

There is no pre-filing requirement or registration fee to vote in the Party Canvass. However, pre-registration for meeting participants is strongly encouraged to expedite sign-in at the meeting. Pre-filing can be completed on line at the FCRC website, <http://www.frederickvagop.org> Alternatively, a pre-file form can also be downloaded from the same website, completed, and mailed to Frederick County Republican Committee, P.O. Box 1688, Winchester, VA 22604 not later than Thursday, April 25<sup>th</sup>, 2019. Forms must be received by the stated deadline. Postmarks do not govern
