OFFICIAL CALL Mass Meeting of Madison County Committee of the Republican Party of Virginia

As Chairman of the Madison County Committee of the Republican Party of Virginia, and pursuant to the Plan of Organization and as recommended and directed by the Committee and the Executive Committee, I, James H. Smith, do hereby issue this Call for a Mass Meeting to be held at the War Memorial, General District Court, 2 Main Street, Madison, Virginia 22727 (or its alternate site as determined by the Chairman), beginning at 7:00 p.m. EST on Wednesday, May 1st, 2019. Registration begins at 5:30 p.m. EST. The primary purpose of the Mass Meeting is to:

1. Elect a candidate(s) to represent the Republican Party in the November 5th, 2019 General Election for the position of Supervisor of The Madison County Board of Supervisors and
2. Elect a candidate(s) to represent the Republican Party in the November 5th, 2019 General Election for the Constitutional Office of Sheriff, Commonwealth's Attorney, Treasurer, and/or Commissioner of Revenue.

Qualifications for Participation

All legal and qualified voters of Madison County, under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing, as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions or primaries encompassing their respective election districts.

In addition to the foregoing, to be in accord with the principles of the Republican Party, a person otherwise qualified hereunder shall not have participated in Virginia in the nominating process of a party other than the Republican Party in the last five years from March 1, 2014. A single exception to this restriction shall be approved for a voter who renounces affiliation with any other party in writing, and who expresses in writing that he/she is in accord with the principles of the Republican Party and intends to support the nominees of the Republican Party in the future.

For Mass Meeting registration, all participants shall be required to provide proof of identity in the form of a valid government or employer-issued photo identification, or by signing an affidavit of identity. Only those individuals who are registered at the Mass Meeting by 7:00 p.m. EST on May 1st, 2019, or who are in line for

registration by that time, will be entitled to register and participate in the Mass Meeting.

Pre-filing Requirements for Candidates

For the Board of Supervisors

Candidates for the Board of Supervisors must submit an official form, by mail only, to the Madison County Republican Committee, P.O. Box 171, Madison, VA 22727. The official form can be downloaded at <http://madisoncountyva.gov/>. All official forms and a non-refundable filing fee of \$200.00 (check or money order made payable to Madison County Republican Committee) must be mailed and received by 6:00 p.m. EST, April 24th, 2019, and postmarks will not govern. Nominations for candidates for the Board of Supervisors will not be permitted from the floor of the Mass Meeting. **If there is only one qualified pre-filed candidate, the Mass Meeting will still occur as scheduled. If there are no qualified pre-filed candidates for either Board of Supervisors or Constitutional Office, the Mass Meeting will be canceled.**

For Constitutional Offices

Candidates for a Constitutional Office must submit an official form, by mail only, to the Madison County Republican Committee, P.O. Box 171, Madison, VA 22727. The official form can be downloaded at <http://madisoncountyva.gov/>. All official forms and a non-refundable filing fee as set forth below (check or money order made payable to Madison County Republican Committee) must be mailed and received by 6:00 p.m. EST, April 24th, 2019, and postmarks will not govern. Nominations for candidates for a Constitutional Office will not be permitted from the floor of the Mass Meeting. **If there is only one qualified pre-filed candidate, the Mass Meeting will still occur as scheduled. If there are no qualified pre-filed candidates for either Board of Supervisors or Constitutional Office, the Mass Meeting will be canceled.**
