Official Call for a Mass Meeting of Fluvanna County Republican Committee By the Republican Party of Virginia

As Chairman of the Fluvanna Republican Committee, and pursuant to the Plan of Organization for the Republican Party of Virginia and as recommended and directed by the Committee, I, Darrell Byers, do hereby issue this Call for a Mass Meeting to be held at the Fluvanna County Library, 214 Commons Blvd. Palmyra, VA 22963 or its alternate site as determined by the Chairman, beginning at 7:00 p.m. EDT on Thursday May2, 2019. Registration begins at 6:00pm EDT. The primary purpose of the Mass Meeting is: Nominating a Republican candidate for the following office, which will be voted for in the GENERAL election on November 5, 2019: Fork Union District Board of Supervisors.

Qualifications for Participation

All legal and qualified voters of the Fork Union District in Fluvanna County, under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin, or sex, **who are in accord with the principles of the Republican Party** and who, if requested, express in open meeting either orally or in writing, as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions, or primaries encompassing their respective election districts. Each voter shall cast their vote only for the candidate that will represent the District in which voter resides.

In addition to the foregoing, to be in accord with the principles of the Republican Party, a person otherwise qualified hereunder shall not have participated in Virginia in the nominating process of a party other than the Republican Party in the last five years from March 1, 2014. A single exception to this restriction shall be approved for a voter that renounces affiliation with any other party in writing, and who expresses in writing that they are in accord with the principles of the Republican Party and intends to support the nominees of the Republican Party in the future.

For Mass Meeting registration, all participants shall be required to provide proof of identity in the form of a valid government or employer-issued photo identification, or by signing an affidavit of identity. Only those individuals who are registered at the Mass Meeting by 7:00 p.m. EDT on Thursday May2, 2019, or who are in line for registration by that time, will be entitled to register and participate in the Mass Meeting. Eligible voters are **urged** to pre-register by downloading a form from www.fluvannarepublican.com/ and mailing to Fluvanna Republican Committee – P.O. Box 114, Palmyra, Va 22963.

Filing Requirements

Candidates for the election or nomination at said mass meeting shall file a written statement by mail to Fluvanna Republican Committee P.O. Box 114, Palmyra, Va 22963, which must be received no later than 6:00 p.m. EDT on Monday, 29, April 2019. **Postmarks will not govern.** There is a \$50.00 filing fee required to file as a candidate.
