

OFFICIAL CALL  
2<sup>nd</sup> and 5<sup>th</sup> Election District Mass Meeting of the Rockingham County  
Republican Committee of the Republican Party of Virginia  
Issued May 16<sup>th</sup>, 2019

As Chairman of the Rockingham County Republican Committee, and pursuant to the Plan of Organization and as recommended by the Committee, I, Dan Cullers, do hereby issue this call for a Mass Meeting to be held at the following location:

Rockingham County Administration Center, 20 East Gay St, Harrisonburg VA 22801  
Board of Supervisors Meeting Room, Main Entrance

At 6:30 PM local time on June 5th, 2019 for the purpose of nominating a Republican candidate for the office of Rockingham County Supervisor for Election District 2 and Rockingham County Supervisor for Election District 5, to be voted for in the election on November 5, 2019.

Qualifications for Participation

All legal and qualified voters of Rockingham County Election Districts 2 & 5, under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin, or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally, or in writing, as may be required, their intent to support all of the nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meeting, party canvasses, conventions, or primaries encompassing their respective election districts.

Each person offering to vote shall present a non-expired photographic identification issued by the Commonwealth of Virginia, one of its political subdivisions, or the United States Government. No absentee voting or proxies will be permitted. There will be no registration fee to participate in this Mass Meeting.

Only legal and qualified voters of Rockingham County Election Districts 2 & 5 shall be eligible to participate.

2<sup>nd</sup> District Precincts: Singers Glen, Edom, Dayton, Mt. Clinton and Silver Lake

5<sup>th</sup> District Precincts: Elkton, Swift Run, McGaheysville, South Fork, Stony Run

Filing Requirements

Candidates for the election at said Mass Meeting shall file a written statement of intent to run to Dan Cullers, 2300 Four Leaf Circle, Dayton, VA 22821, which must be received no later than 5:00 PM, May 31<sup>st</sup>, 2019. Postmarks shall not govern. The statement must be accompanied by a filing fee of \$300, payable to the Rockingham County Republican Committee. If only one candidate properly files by the deadline of 5:00 PM, May 31<sup>st</sup>, 2019, then said candidate shall be declared the Republican nominee and no mass meeting will be held. If no candidate properly files by the deadline of 5:00 PM, May 31<sup>st</sup>, 2019, the mass meeting shall be cancelled and no candidate shall be nominated.

Approval of this call by a 2/3 majority shall remove the requirement to publish this call in a newspaper of general circulation in the election district.
