I hereby seek election as a **Delegate** representing Chesterfield County at the **Fourth Congressional District Convention** to be held on Saturday, April 25, 2020 at the Thomas Dale High School-West Campus Gymnasium located at 3626 West Hundred Rd., Chester, VA 23831. *Only voters in the FOURTH DISTRICT portion of Chesterfield are eligible.*

I hereby seek election as a **Delegate** representing Chesterfield County at the **Seventh Congressional District Convention** to be held on Saturday, April 25, 2020 at the Arthur Ashe, Jr. Athletic Center located at 3001 N Arthur Ashe Blvd., Richmond, VA 23230. *Only voters in the SEVENTH DISTRICT portion of Chesterfield are eligible.*

A voluntary fee of \$25.00 is attached.

I hereby seek election as a **Delegate** representing Chesterfield County at the **2020 Republican State Convention** to be held on May 1-2, 2020 in Lynchburg, VA, or its alternate site.

A voluntary fee of \$35.00 is attached.

NOTE: Article VII, Section C of the Republican Party of Virginia's Plan of Organization states the following about membership on a county committee:

A member of an Official Committee is held to a higher standard of support for nominees of the Republican Party than an individual who merely participates in a mass meeting, party canvass, convention or primary. Therefore, a member of an Official Committee is deemed to have resigned his Committee position if he (a) makes a reportable contribution to and/or (b) allows his name to be publicly used by and/or (c) makes a written or other public statement in support of a candidate in opposition to a Republican nominee in a Virginia General or Special Election.

By signing this form, I certify that I am a registered voter in Chesterfield County, have read and understand the requirements above and that I intend to support all nominees of the Republican Party during this election (for convention delegates) and/or during my two-year term as a member of the Chesterfield County Republican Committee. Also, I have read and understand other requirements herein including, but not limited to Article I of the Plan of Organization which states in part:

A voter who, subsequent to making a statement of intent, publicly supports a candidate in opposition to a Republican nominee shall not be qualified for participation in party actions as defined in Article I for a period of four (4) years.
