

OFFICIAL CALL

2020 MASS MEETING

OF THE CITY OF FAIRFAX REPUBLICAN PARTY

As Chairman of the City of Fairfax Republican Committee of the Republican Party, and pursuant to the plan of organization and as recommended and directed by the committee, I, Becky A. Stoeckel, do hereby issue this call for a MASS MEETING to be held at The Old Firestation #3, 3988 University Drive (upstairs), Fairfax, VA 22030 on **Saturday, March 14, 2020**, starting at 8:00 PM, for the following purposes:

- a) Electing a Unit Chairman;
- b) Electing up to 70 members to the City of Fairfax Republican Committee;
- c) Electing up to 130 Delegates and 130 Alternate Delegates to the 11th Congressional District convention to be held on Saturday, May 30, 2020 beginning at 10:00 AM at Waterford at Fair Oaks, 12025 Lee Jackson Memorial Highway, Fairfax, Virginia 22033.

The purposes of the District Convention are to:

- 1) elect a District Chairman;
 - 2) elect 3 members of the State Central Committee;
 - 3) nominate a Republican candidate for member of the U.S. House of Representatives to be voted for at the election on Tuesday, November 3, 2020;
 - 4) nominate a Presidential Elector;
 - 5) elect 3 Delegates and 3 Alternate Delegates to the Republican National Convention.
- d) Electing up to 130 Delegates and 130 Alternate Delegates to the Republican Party of Virginia State Convention to be held May 1 – 2, 2020 at the Greater Richmond Convention Center, 403 N 3rd Street, Richmond, VA 23219, or its alternate location

The purposes of the State Convention are to:

- 1) elect a State Chairman;
 - 2) elect a National Committeeman and a National Committeewoman;
 - 3) nominate two At-Large Presidential Electors; and
 - 4) elect 12 At-Large Delegates (“National Delegates”) and 12 At-Large Alternate Delegates (“National Alternates”) to the Republican National Convention to be held on August 24 – 27, 2020 at the Spectrum Center, Charlotte, NC in (or its alternate site), for the purpose of nominating candidates for President and Vice President of the United States.
- e) For transaction of such other business as may properly come before the mass meeting.

QUALIFICATIONS FOR PARTICIPATION

All legal and qualified voters under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party, and who, if requested, express in open meeting either orally or in writing as may be required their intent to support all of its nominees for public office in the ensuing election may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions, or primaries encompassing their respective election districts.

BALLOTING

All properly registered attendees at the Mass Meeting shall be permitted to vote. Balloting shall not begin before 8:30 PM. At the Mass Meeting, Delegates and Alternate Delegates must present one of the forms of identification listed in § 24.2-643 of the Code of Virginia in order to participate.

REGISTRATION

Mass Meeting registration shall begin at 7:30 PM and shall conclude at 8:30 PM. The Mass Meeting shall be called to order at 8:00 PM. Upon commencement of the first ballot for any office and thereafter, no quorum call or point of order regarding the quorum of the Mass Meeting or of any committee thereof shall be in order.

FILING FORMS AND PREFILING REQUIREMENTS

Official Filing Forms are available for download at www.rpv.org; or you may request a copy by mail by writing to COFRC Chairman Becky Stoeckel, 10412 Main Street, Fairfax, VA 22030 or via email to epi.becky@gmail.com.

Prefiling to participate in the Mass Meeting is encouraged, but not required. Prefiling **is required** for those wishing to be elected as City Chairman, Delegate or Alternate Delegate to the District Convention, Delegate or Alternate Delegate to the State Convention, and/or to be elected as a member of the City Republican Committee.

All filing forms must be signed originals. No faxed or emailed forms are acceptable. Each person must file on a separate form and all necessary fees for each separate filing shall be attached to such filing. Each filing form shall have a separate personal check or money order for any applicable filing fees attached to such form. All filing forms must be reasonably legible and contain all mandatory information requested therein. All noncompliant forms shall be subject to rejection, and funds attached to such noncompliant forms shall be deemed contributions to the City of Fairfax Republican Committee.

MILITARY MEMBERS AS DELEGATES

Military Members (any members of the Virginia National Guard, or the United States Armed Forces, Merchant Marine, or Coast Guard currently serving on active duty) who comply with these filing requirements shall not be required to be elected, but shall be declared delegates pursuant to Article VIII, Section H. of the Plan of Organization of the Republican Party of Virginia.

Military Member delegates or alternate delegates that are unable to attend the convention in person due to obligations of their official military orders, shall have their votes cast within their unit delegation according to candidate preference ballots. Instructions regarding the casting of candidate preference ballots are available in the Call for the Convention, which is available on the website of the Republican Party of Virginia (www.rpv.org).

FILING FOR CHAIRMAN OF THE CITY OF FAIRFAX REPUBLICAN COMMITTEE

Any person who desires to seek election as Chairman of the City of Fairfax Republican Committee must file in writing on the Official COFRC Filing Form, and include a non-refundable filing fee of \$50.00 (Fifty dollars and zero cents), with the City of Fairfax Republican Committee Chairman Mrs. Becky Stoeckel, or her designee, accepting applications at 10412 Main Street, Fairfax, VA 22030, prior to **6:00 PM, Thursday, March 12, 2020** (postmark shall not count).

FILING FOR COMMITTEE MEMBERSHIP

Candidates for Membership to the City of Fairfax Republican Committee must file in writing on the Official COFRC Filing Form and include a non-refundable filing fee of \$20.00 (Twenty dollars and zero cents) with the COFRC Chairman Mrs. Becky Stoeckel, or her designee, accepting applications at 10412 Main Street, Fairfax, VA 22030, prior to **6:00 PM, Thursday, March 12, 2020** (postmark shall not count). The filing fee for Committee membership will be applied to the first year's dues for City Committee membership. Election as a committee member shall be based first on Precinct and then At-Large. No individual will be elected to more than one level of membership.

ADDITIONAL APPLICABLE FEES

A \$10.00 (Ten dollars and zero cents) voluntary registration fee is requested to participate in the Mass Meeting to help defray expenses associated with the Mass Meeting.

A \$20.00 (Twenty dollars and zero cents) filing fee is requested for each Candidate for Delegate and Alternate Delegate to the 11th Congressional District Convention. The filing fee is voluntary for those individuals who wish to participate only in the elections for 11th District Republican nominee for Congress, Presidential Elector, Delegate and Alternate Delegate to the Republican National Convention. The filing fee is mandatory for those individuals who wish to participate in the intra-party elections for District Chairman and State Central Committee Members.

A \$35.00 (Thirty-five dollars and zero cents) filing fee is requested for each Candidate for Delegate and Alternate Delegate to the Republican Party of Virginia State Convention. The filing fee is voluntary for those individuals who wish to participate only in the Presidential Preference Poll. The filing fee is mandatory for those individuals who wish to participate in the intra-party elections for State Chairman, National Committeeman and National Committeewoman.

All applicable fees must accompany the Official COFRC Filing Form. All payments must be made by personal check or money order, payable to the City of Fairfax Republican Committee. No company/business checks can be accepted. Cash payments can be accepted only when filing in person. Filing and/or registration fees are non-refundable and are not deductible as charitable contributions for income tax purposes.

GENERAL RULES

The State Party Plan, the Call of the Mass Meeting, and the Rules adopted by the Mass Meeting shall take precedence in governing the Mass Meeting. Robert's Rules of Order, *Newly Revised*, shall also govern insofar as they do not conflict with the State Party Plan, the Call of the Mass Meeting, and the Mass Meeting Rules.

At the closing of the pre-filing deadline, at 6:00 PM on March 12th, if fewer than the maximum number of candidates that can be elected at the Mass Meeting are filed, all properly filed candidates shall be deemed elected and NO Mass Meeting will be held. A notice of cancellation will be posted on the website of the Republican Party of Virginia (www.rpv.org).

By unanimous consent of the Committee the publication of the Call in a newspaper is waived. A full copy of this Call for Mass Meeting, including the Official Filing Form, shall be posted and available via download, on the Republican Party of Virginia website (www.rpv.org). PRE-FILING AND REGISTRATION FORM**

A City of Fairfax Republican Party Mass Meeting will be held on **Saturday, March 14, 2020** at Old Firestation #3, 3988 University Drive (upstairs), Fairfax, VA 22030, at 8:00 p.m. Sign-in will BEGIN at 7:30 p.m. and CLOSE at 8:30 p.m. Only those who properly sign in and meet the qualifications and conditions stipulated in the Call will be permitted to participate in the proceedings of the Mass Meeting.

PREFILING REQUIREMENTS: Prefiling for the Mass Meeting is encouraged, but not required, to participate in the City of Fairfax Republican party Mass Meeting. However, prefiling is required of all candidates for election at the Mass Meeting, specifically: (1) Candidates for delegate to the 11th District Convention, (2) Candidates for delegate to the State Convention, (3) Candidates for membership in the City of Fairfax Republican Committee, and (4) Candidates for Chairman. (postmark shall not count).

Prefiling Location, Deadline, and Procedures: Completed prefiling forms and applicable payments for candidates for election must be received no later than **6:00 p.m., March 12, 2020** by the City of Fairfax Republican Committee Chairman Mrs. Becky Stoeckel or her designee, accepting applications at 10412 Main Street, Fairfax, VA 22030 (postmark shall not count).

Prefiling Receipts: Receipts can be provided if form is submitted in person. If you mail your form and want a receipt please include a self addressed, stamped envelope. Presentation of the prefiling receipt at sign in to the Mass Meeting will assist in demonstrating that prefiling was properly accomplished before the deadline.

Payments: Make SEPARATE check or money order FOR EACH PERSON, payable to City of Fairfax Republican Committee. Payments are not tax-deductible. No company/business checks. Cash payments can be accepted only when filing in person. All fees are non-refundable.

Required Affidavit: I, the undersigned, hereby swear or affirm that I do not intend to participate in the nomination process of any party other than the Republican Party and I intend to support the Republican nominee(s) for public office for the Election to be held on Tuesday, November 3, 2020.
