

## OFFICIAL CALL

### Mass Meeting of Emporia/Greensville Republican Committee of the Republican Party of Virginia

As Chairman of the 4th Congressional District Republican Committee of the Republican Party of Virginia, and pursuant to the Plan of Organization and as recommended and directed by the Committee, I, **Carey Lynn Allen**, do hereby issue this call for a Mass Meeting to be held at **Emporia Municipal Building, 201 South Main Street, Emporia, Virginia 23847** starting at **7:00 p.m.** local time on **March 24, 2020** for the following purposes:

- A. Electing up to 30 Delegates (Emporia)/59 Delegates (Greensville) and an equal number of alternates to the Republican Party of Virginia's 4<sup>th</sup> District Convention, to be held on **April 25, 2020** at the **Thomas Dale High School - West Campus, 3900 W Hundred Road, Chester, VA 23831** or its alternate site, beginning at **10:00 a.m.** local time for the following purposes:
  - a. Electing a Chairman for the 4th Congressional District Republican Committee;
  - b. Electing three National Delegates and three Alternate Delegates to the National Convention;
  - c. Nominating one Elector to be voted for in the presidential election on Nov. 3, 2020;
  - d. Electing three 4<sup>th</sup> District members to Republican Party of Virginia State Central Committee;
  - e. And for the transaction of such other business as may properly come before the convention.
  
- B. Electing up to 18 Delegates and an equal number of alternates to the Republican Party of Virginia's State Convention, to be held beginning at **2:30 p.m. on Friday, May 1, 2020**, at the **Greater Richmond Convention Center, 403 N 3rd St, Richmond, VA 23219** or its alternate site for the following purposes.
  - a. Electing a State Chairman;
  - b. Electing 12 At-Large Delegates ("National Delegates") and 12 At-Large Alternate Delegates ("National Alternates") to the National Republican Convention to be held on Mon, Aug 24, 2020 – Thu, Aug 27, 2020 at the Spectrum Center in Charlotte, North Carolina (or its alternate site) (the National Convention);
  - c. Nominating two Electors At-Large to be voted for in the presidential election on Nov. 3, 2020;
  - d. Electing a National Committeeman and National Committeewoman;
  - e. And for the transaction of such other business as may properly come before the convention.

Each unit is entitled to one (1) Delegate Vote per 250 Republican votes for Governor and President at their last election, so that Emporia/Greensville is entitled to 18 Delegate Votes at the convention.

#### Qualifications for Participation

All legal and qualified voters of Emporia/Greensville under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions or primaries encompassing their respective election districts.

### Filing Requirements

Candidates for election as delegate to any convention at said mass meeting shall file a written statement, on the form provided, in person, to **Emporia Municipal Building**, 201 South Main Street, Emporia, Virginia 23847 .Filing forms can be picked up on March 24, 2020 at 7pm at **Emporia Municipal Building**, 201 South Main Street, Emporia, Virginia 23847 or online at [www.RPV.org](http://www.RPV.org).

### Active Duty Military

Any Military Member who is otherwise qualified to participate in Republican Party actions and who has filed the required form and produced at the time of filing valid military identification or other proof of active-duty status, shall be certified as a delegate to the convention(s) filed for, and shall not be required to be elected as a delegate.

### Registration Fees

To assist the operations of the Republican Party of Virginia in supporting unit mass meetings and conventions, and the administration of the State Convention, a candidate filing fee of Thirty-Five Dollars (**\$35.00**) is requested of each person standing for election as a delegate or alternate delegate to the Convention. Failure to pay the requested filing fee will not result in disqualification. **Please make your check payable to the 4th Congressional District Republican Committee and return with your Delegate Form. There is no fee required to participate in the Emporia/Greenville Republican Mass Meeting or the 4th Congressional District Republican Committee Convention.**
