Mass Meeting
Franklin County Republican Committee

As Chairman of the Franklin County Committee of the Republican Party of Virginia, and pursuant to the Plan of Organization and as recommended and directed by the Committee, I, Walter W. Young do hereby issue this Call for a Mass Meeting to be held on Saturday, March 21, 2020 at 10:00 AM at the location of:

Boones Mill Baptist Church
234 Winding Way Road
Boones Mill, VA 24065

The purpose of the Mass Meeting is to:

- A. Elect a Chairman of the Franklin County Republican Committee for a two-year term (2020-2022).
- B. Elect members of the unit committee and the following officers: Vice Chair, Second Vice Chair, Secretary, and Treasurer.
- C. Elect up to 615 Delegates and an equal number of Alternates to the Convention of the 5th Congressional District Republican Committee, to be held on Saturday, April 25, 2020, at 11:00 AM, at Tree of Life Ministries, 2812 Greenview Drive, Lynchburg, VA 24502. Franklin County is entitled to 123 Delegate Votes.
- D. Elect up to 615 Delegates and equal number of Alternates to the State Convention to be held in Richmond, VA on May 1st and 2nd, 2020 beginning at 10:00AM for the purpose of (1) election of a candidate to run for the President of the United States, and (2) Transaction of such other business as may properly come before the Convention.
- E. For the transaction of such other business as may properly come before the Mass Meeting.

QUALIFICATIONS FOR PARTICIPATION:

All legal and qualified voters of the Franklin County, under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as a member of the Republican Party of Virginia in this Franklin County Republican Committee Mass Meeting.

REGISTRATION:

Mass Meeting registration shall begin at 9:00 AM and shall conclude at 10:00 AM. All Delegates in line at 10:00 AM shall be allowed to register. The Mass Meeting shall be called to order at 10:00 AM or upon registration of all the Delegates in line at 10:00 AM. For Mass Meeting registration, all participants shall be required to provide proof of identity in the form of a valid government issued photo identification, or by signing an affidavit of identity. Only those individuals who are registered at the Mass Meeting by 10:00 AM on March 21, 2020 or who are in line for registration by that time will be entitled to register and participate in the Mass Meeting.

FILING REQUIREMENTS - Franklin County Republican Committee Chairman

Candidates for election or nomination at said Mass Meeting shall pre-file a written statement declaring their intent to run for the office of Chairman and submit it by email to FCRCGOP@gmail.com with cc to FCRCSEC@gmail.com. Statements must be received by 5:00 PM on March 7, 2020. Postmarks do not apply. It is the responsibility of the candidate to confirm receipt of the declaration with the Chairman. No nominations shall be accepted from the floor of the Mass Meeting.

FILING REQUIREMENTS - 5th District Convention Delegate

Delegate candidates for election to the 5th District Convention shall file an application beginning February 8, 2020 and ending at 5:00 PM, March 7, 2020. Postmarks do not govern. The application is attached to this call. Completed and signed applications shall be emailed to FCRCGOP@gmail.com or FCRCSEC@gmail.com or can be hand delivered to any officer of the unit i.e. Chairman, Secretary, Treasurer.

REGISTRATION FEES

The Republican Committee of the 5th Congressional District is requesting a voluntary filing fee of \$25.00 from all individuals seeking election as a Delegate to the 5th Congressional District Convention.
