

OFFICIAL CALL

Mecklenburg County Republican Committee (MCRC) Mass Meeting Of the Republican Party of Virginia

As Chairman of the Mecklenburg County Republican Committee (MCRC), and pursuant to the Plan of Organization and as recommended and directed by the County Committee, I, R. Wallace Hudson, Chairman, do hereby issue this call for a Mass Meeting to be held at the Southside Regional Library at 1294 Jefferson Street, Boydton, VA 23917 starting at 7:00 PM local time on Tuesday March 10, 2020 for the purpose of:

- 1) Elect a Committee Chairman
- 2) Elect members of the committee, and the following officers: Committee Vice-Chairman, a Committee Secretary, and a Committee Treasurer.
- 3) Elect up to 270 Delegates and an equal number of alternates to the 5th District Convention. The MCRC has 54 votes. The 5th District Convention will be held on April 25, 2020 in Campbell County at 10:00 AM at:

Its alternate site beginning at 10:00 am for the purpose of:

- (1) Electing a chairperson for the 5th District, (2) Electing a candidate to run for Congress of the United States, (3) Election of 3 Delegates and 3 alternates for the 2020 Republican National Convention, (4) Election of 3 State Central Committee Members, (5) Election of 1 Elector for the 2020 Presidential Election, (6) Transaction of such other business as may properly come before the Convention.
- 4) Elect up to 270 Delegates and equal number of alternates to the State Convention to be held in Richmond, VA on May 1st and 2nd, 2020 beginning at 10:00 AM for the purpose of (1) Election of a candidate to run for the President of the United States, and (2) Transaction of such business as may properly come before the Convention.

Qualifications for Participation

All legal and qualified voters of the County of Mecklenburg under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meeting, party canvasses, conventions or primaries encompassing their respective election districts.

Filing Requirements

Delegates to the 5th District Convention must file an official form which is attached to this Call and available at **5thdistrictva.gov/** These forms must be filed by mail or in person to the Chairman's address below. Committee Officer Candidates for the election or nomination at said mass meeting shall file a written statement by mail or in person to:

All forms must be received no later than 5:00 pm on March 4, 2020. Postmarks DO NOT govern.

Should only one candidate each file for all unit offices and no more than 270 delegates file for the 5th District Convention, then the mass meeting may be cancelled.
