

OFFICIAL CALL

Manassas Park Republican Committee

March 28, 2020 Mass Meeting

As Chairman of the Manassas Park Committee (MPRC) of the Republican Party of Virginia, and pursuant to the Plan of Organization and as directed by the Committee, I, Preston Banks, do hereby issue this call for a Mass Meeting to be held at the Community Room at the Manassas Park Police Department, 329 Manassas Dr., Manassas Park, VA 20111, with registration from 10:00 AM until 11:00 AM, the meeting will start after registration or at 11:00 AM on Sunday, March 28, 2020, for the following purposes:

A.) To elect up to 60 (12 votes x 5) Delegates and up to 36 Alternate Delegates to the 10th Congressional District Republican Convention to be held at 11:00 AM, Saturday May 30, 2020, at Shenandoah University, James R. Wilkins, Jr. Athletics & Events Center, 1188 Ralph Shockey Drive, Winchester, Virginia 22602 for the purposes of:

-Electing a District Chairman,

-Nominating a Republican candidate for member of the U.S. House of Representatives to be voted for in the election on November 3, 2020,

-Nominating Presidential Elector to be voted for in the election on November 3, 2020,

-Electing three members to represent the 10th District on the State Central Committee of the Republican Party of Virginia, and

-Electing three Delegates and three Alternate Delegates to the Republican National Convention to be held in Charlotte, North Carolina from August 24 – 27, 2020.

Each unit is entitled to one (1) Delegate Vote per 250 Republican votes for Governor and President at their last election, so that Manassas Park is entitled to 466 Delegate Votes and may send up to five delegates for each vote.

B.) To elect up to 60 (12 votes x 5) Delegates and up to 36 Alternate Delegates to the Republican Party of Virginia Convention to be held on May 1-2, 2020 at Liberty University Vine Center, 1971 University Boulevard, Lynchburg, Virginia 24502 for the purposes of:

- Electing a State Party Chairman,
- Nominating a Republican National Committee (RNC) Committeeman and Committeewoman,
- Electing 12 At-Large Delegates and 12 At-Large Alternate Delegates to the RNC Convention,
- Nominating two At-Large Presidential Electors to be voted for in the election on November 3, 2020, and
- Binding Virginia Delegates to the RNC Convention as to their choice for President on the first ballot by a Presidential Preference Poll.

Each unit is entitled to one (1) Delegate Vote per 250 Republican votes for Governor and President at their last election, so that Manassas Park is entitled to 12 Delegate Votes and may send up to five delegates for each vote;

C.) And for the transaction of such other business as may properly come before the Mass Meeting. There shall be no resolutions brought before the Manassas Park Republican Committee Mass Meeting.

Qualifications for Participation

All legal and qualified voters of the City of Manassas Park under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia participate in this Mass Meeting, subject to the provisions in Article I of the Plan of Organization.

All persons wishing to participate in the Mass Meeting must present themselves during registration times listed above to verify and receive their credentials. Those in line at the close of registration shall be permitted to register, but no one shall join the line after 8:00 PM.

Mass Meeting participants must present one of the forms of identification listed in § 24.2-643 of the Code of Virginia in order to participate.

Filing Requirements for Committee Membership and Delegate

Candidates for Delegate to the Congressional District Convention, State Convention and/or

membership to the Manassas Park Republican Committee must meet the above qualifications, and shall contact Preston Banks, Committee Chairman, 9463 Russia Branch View Dr. #1436, Manassas Park, (703) 586-5300, and return same with the appropriate fee(s) by U.S. mail to the Preston Banks, Manassas Park Republican Committee Chairman, 9463 Russia Branch View Dr. #1436, Manassas Park VA 20111, or by delivery to Preston Banks, Committee Chairman, 9463 Russia Branch View Dr. #1436, Manassas Park, (703) 586-5300 not later than 5:00 PM on Sunday, March 28, 2020.

Postmarks shall not govern. The form must have an original wet ink signature. The filing form will include a Statement of Qualification that must be signed by the person indicating his/her intent to support all Republican nominees in the ensuing election. Only candidates who have properly filed by the stated date and time with the required fee shall be eligible for election. There shall be no nominations from the floor of the Mass Meeting.

Military Members as Delegates

Military Members (any members of the Virginia National Guard, or the United States Armed Forces, Merchant Marine, or Coast Guard currently serving on active duty) who comply with these filing requirements shall not be required to be elected, but shall be declared delegates pursuant to Article VIII, Section H. of the Plan of Organization of the Republican Party of Virginia.

Military Member delegates or alternate delegates that are unable to attend the convention in person due to obligations of their official military orders, shall have their votes cast within their unit delegation according to candidate preference ballots. Instructions regarding the casting of candidate preference ballots are available in the Call for the Convention, which is available on the website of the Republican Party of Virginia (<https://virginia.gov/event/district-convention-of-thetenth-congressional-district/> and <https://virginia.gov/rpv-convention/>).

Filing Fees

Candidates for the above elections shall pay a filing fee in accordance with the following schedule:

A.) Candidate for Member of the Manassas Park Republican Committee:
(required non-refundable fee) \$20

B.) Candidate for Delegate to 10th District Convention
(voluntary non-refundable fee for 10th District Convention if only voting for public offices; required if voting for party offices): \$25

C.) Candidate for Delegate to Republican Party of Virginia Convention (voluntary non-refundable fee for RPV Convention if only voting for public offices; required if voting for party offices): \$35

Cancellation

If the number of candidates who file for all offices to be elected at the Mass Meeting (MPRC Member, Delegate to the 10th District Convention and Delegate to the RPV Convention) does not exceed the maximum number that can be elected, then all duly filed candidates shall be deemed elected and the Mass Meeting will be canceled.

Mass Meeting Committees

Chairman and members of the Mass Meeting Committees shall be appointed by the MPRC

Chairman and shall meet in advance of the Mass Meeting on the call of the appointed Committee

Chairmen and/or the MPRC Chairman to perform their duties. These committees shall include

Nominations, Credentials, Rules, Tellers, and any other committees that the Manassas Park Republican Chairman deems necessary. The Mass Meeting Committees will be confirmed by the Mass Meeting and all

recommendations of a Committee must be approved by the Mass Meeting. This Call for a Mass Meeting shall be published on the Republican Party of Virginia website as well as the Manassas Park Republican Committee Facebook website. With the approval of this Call, the Manassas Park Republican Committee hereby waives publication in a newspaper of general circulation.
