Candidates for the above elections shall file this official filing form with the appropriate fee(s) by U.S. mail or delivery to **Preston Banks, 9463 Russia Branch View Dr. #1436, Manassas Park, VA 20111, NOT LATER THAN 5:00 PM ON SUNDAY, MARCH 28, 2020. POSTMARKS SHALL NOT GOVERN.** Illegible, incomplete, or invalid filings, and any altered or changed reproductions of the Official Filing Form, will be subject to rejection, and accompanying fees will be deemed contributions to the Manassas Park Republican Committee.

I am a legal and qualified voter of the City of Manassas Park, under the laws of the Commonwealth of Virginia, who is in accord with the principles of the Republican Party, and who, if requested, will express in open meeting either orally or in writing as may be required, my intent to support all of its nominees for public office in the ensuing election. I have not participated in Virginia in the nomination process of a party other than the Republican Party in the last five years, but if I have, I now renounce affiliation with any other political party.
