

OFFICIAL CALL
Legislative District Party Canvass
of the 29th House District Legislative District Republican Committee
of the Republican Party of Virginia

As Chairman of the 29th House District Legislative District Republican Committee of the Republican Party of Virginia (Legislative District Committee), and pursuant to the Plan of Organization and as recommended and directed by the Committee, I, Allen Sibert, do hereby issue this call for a Legislative District Party Canvass to be held at Millwood Station Banquet Hall, 252 Costello Drive, Winchester, VA 22602, or alternate location, from 9:00 AM until 4:00 PM local time on Saturday, August 8, 2020 for the purpose of nominating a Republican candidate for the office of Delegate to be voted for in the Special Election on November 3, 2020.

Qualifications for Participation

All legal and qualified voters of the 29th House District under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions or primaries encompassing their respective election districts.

Filing Requirements

Candidates for the Republican nomination at said canvass shall file a written statement, on the official filing form provided by the Legislative District Committee, by mail or in person, to Robert Hess, 429 Castleman Drive, Winchester, VA 22601, which must be received not later than 5:00 PM local time, Friday, July 31, 2020. A copy of the filing form is included as a part of this Call or may be obtained from the individual listed above. A filing fee of \$700.00 payable to the Frederick County Republican Committee must accompany the filing form. The filing deadline is for physical receipt of the form and filing fee. Postmarks are not evidence of receipt by the deadline and shall not govern. Only candidates who have properly filed by the stated date and time with the required fee shall be eligible for election. No write-in votes will be permitted at the Party Canvass. If only one candidate properly files, then said candidate shall be declared the Republican nominee and no canvass will be held.

Registration Fee

There will be no registration fee required to participate in this canvass. A voluntary registration fee of \$10.00 is requested of each voter in this canvass.

The filing deadline is 5:00 PM local time, Friday, July 31, 2020. Please note the deadline is for physical receipt of the form and filing fees; postmarks shall not govern. Only candidates who have properly filed by the stated date and time with the required fee shall be eligible for election. No write-in votes will be permitted at the Party Canvass.
