

## Official Call

2021 Party Canvass of the Roanoke County Republican Party for the Vinton Magisterial District Supervisor

As Chairman of the Roanoke County Republican Committee, and pursuant to the Plan of Organization and as recommended and directed by the Committee, I, Dan Webb, do hereby issue this call for a Party Canvass to be held at

Lighthouse Bible Church, 2500 E Washington Ave, Vinton, VA 24179

From 10:00 a.m. to 3:00 p.m. local time on May 22, 2021 for the following purpose of nominating a Republican candidate for the office of Vinton District Supervisor to be voted for in the general election on November 2nd. No voter may vote more than once.

**Qualifications for Participation.** All legal and qualified voters of the Roanoke County Vinton Magisterial District under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions or primaries encompassing their respective election districts. Voters will be required to present a validly issued photographic identification as defined by the Virginia Department of Elections. No voter who refuses to present such identification will be permitted to vote.

**Filing Requirements** Candidates for the nomination or election at said canvass shall file a written statement by mail or in person (application attached), and pay a \$700 filing fee to Ken Srpan, 2009 Montclair Dr. Roanoke, VA 24019 which must be received not later than 5 p.m. on Tuesday, February 23. If not more than the number of persons to be elected shall file for each office, then such properly filed persons shall be declared nominated or elected as the case may be, and no canvass will be held for such purpose. Postmarks shall not govern.

**Approval/Publication/Revisions** The Roanoke County Republican Committee voted at a duly called meeting on January 28, 2021, to approve the terms of this Call, authorize the Credentials Committee to make technical changes if required and to change the location of any Canvass site if any of the above-chosen locations is not available, and to waive publication of this Call in a newspaper. ## *Declaration and Statement of Qualifications*

I am a registered voter in the Vinton Magisterial District;

I have NOT participated in the nominating process of another party in the last five years; OR

I have participated in the nominating process of another party in the last five years, but I renounce affiliation with any party other than the Republican Party, intend to support the nominees of the Republican Party in the future and understand that the Roanoke County Republican Committee shall provide a copy of this signed renunciation statement to the Republican Party of Virginia, to be maintained for a period of five years.
