To Elect Delegates to the Republican Party of Virginia Convention

As Chairman of the New Kent County Republican Committee of the Republican Party of Virginia, pursuant to the Plan of Organization and as recommended by the Committee, I, Mark Daniel, do hereby issue this call to elect delegates to the May 8, 2021, RPV State Convention at which candidates for Governor, Lieutenant Governor, and Attorney General will be selected between 9:00 A.M. and 4:00 P.M.

Qualifications for Participation

All legal and qualified voters of the NKCRC under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin, or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions, or primaries encompassing their respective election districts.

Filing Requirements

Those wishing to serve as delegates to the State Convention shall file the **Convention Delegate Filing Form** which is available at

The form must be received no later than **April 13, 2021**, as specified below.
