**Official Call**

*2021 Party Canvass of the Craig County Republican Party  
for the Simmonsville Magisterial District Supervisor*

As Chairman of the Craig County Republican Committee, and pursuant to the Plan of Organization and as recommended and directed by the Committee, I, C. Jordan Labiosa, **do hereby issue this call for a Party Canvass to be held at Joe's Trees, 5110 Cumberland Gap Rd, Newport, VA 24128 or an alternate location from 12 PM to 5 PM local time on May 22, 2021** for the purpose of nominating a Republican candidate for the office of Simmonsville District Supervisor to be voted for in the election on November 2nd. No voter may vote more than once.

**Qualifications for Participation.** All legal and qualified voters of the Craig County Simmonsville Magisterial District under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions or primaries encompassing their respective election districts. Voters will be required to present a validly issued photographic identification as defined by the Virginia Department of Elections. No voter who refuses to present such identification will be permitted to vote.

**Filing Requirements**

Candidates for the nomination at said canvass shall complete the official filing form and submit it by mail to P.O. Box 157, New Castle, VA 24127 or in person by appointment which can be made by calling 540-597-5349, and pay a \$200 filing fee to the Craig County Republican Committee. Both form and filing fee must be received no later than 7 P.M. on May, 1st. If not more than the number of persons to be elected shall file for each office, then such properly filed persons shall be declared nominated, and no canvass will be held for such purpose. Postmarks shall not govern. Filing fees are not refundable.

**Election Committee/Rules**

The Chairman of the Craig County Republican Committee shall appoint an Elections Committee which will be responsible for drafting and adopting rules for the canvass within seven days of the adoption of this call and will be responsible for conducting the Canvass. No rule adopted shall be construed to violate any terms of this Call or the Party Plan of the Republican Party of Virginia. The Elections Committee shall be authorized to make technical changes if required and to change the location of the Canvass site if the above-chosen location is not available.

**Approval/Publication**

The Craig County Republican Committee votes to approve the terms of this Call and to waive publication of this Call in a newspaper of general circulation.
