

OFFICIAL CALL

Election of Delegates to the 2021 Republican Party of Virginia State Convention King William County Republican Committee

As Chairman of the King William County Republican Committee of the Republican Party of Virginia, and pursuant of the Plan of Organization and as directed by the Committee, I, John R. Hubbard, do hereby issue this call for a Party Canvass for the following purposes:

- (1) To elect delegates to the May 8, 2021 Republican Party of Virginia State Convention to be held at a location to be posted on the website of the Republican Party of Virginia no later than April 24, 2021. Voting at the State Convention will take place from 9:00 a.m. – 4:00 p.m.

The purpose of the State Convention is to nominate a Republican candidate for Governor, Lieutenant Governor, and Attorney General for the general election to be held on November 2, 2021.

Each unit is entitled to one (1) Delegate Vote per 250 Republican votes for Governor and President at their last election, such that King William County is entitled to 45 Delegate Votes at the 2021 Republican State Convention. There are no limits on the individuals that can file to be delegates to cast King William counties 45 Delegate Votes at the 2021 State Convention.

Qualifications for Participation

All legal and qualified voters of King William County under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions or primaries encompassing their respective election districts.

Military Provision

Any Military Member who is otherwise qualified under Article I to participate in Republican Party actions and who complies with the procedures to become a delegate to the Convention, and who produces valid military identification or other proof of active-duty status shall be certified as a delegate and shall not be required to be elected as a delegate. Military Members who are certified as delegates pursuant to the preceding paragraph that are unable to attend the convention in person due to obligations of their official military orders, shall have their votes cast within their unit delegation. Military Member ballots shall be made available by the RPV Chairman or his designee at least twenty (20) days prior to the convention (April 18, 2021). Ballots must be received by the RPV Chairman no later than 12:30 pm on Wednesday, May 5, 2021.

Pre-Filing Requirements

Each individual wishing to serve as a delegate to the State Convention shall file in one of two ways:

- (1) Completing and printing the prefiling form available at:
virginia.gop/events/category/official-call/ .
- (2) These forms must be submitted either by mail or in person John R. Hubbard, 115 Commerce Park Dr., Suite E, Manquin Va. 23106, and must be received not later than 5:00 p.m. on Monday, April 19, 2021. Postmarks shall not govern.

- (3) Electronic filing of form by emailing to kwgop@3riversservices.com
Electronic filing must be emailed not later than 5:00 p.m. on Monday, April 19, 2021.

Registration Fee

There will be no registration fee to a delegate to the State Convention.

Election of Delegates

Pursuant to Article VII and Article XII of the State Party Plan, all individuals who properly prefile and qualify under Article I of the State Party Plan will be deemed elected, and no Party Canvass will be held.

Publication

This call will be published at virginia.gop. The Unit Committee has eliminated the requirement to publish this call in a newspaper of general circulation by a two-thirds vote.
