**OFFICIAL CALL**  
**Legislative District Mass Meeting**

As Chairman of the 57<sup>th</sup> Legislative District Committee for the House of Delegates, and pursuant to the Plan of Organization and as recommended and directed by the Committee, I, Dan Moy, do hereby issue this call for a Legislative District Mass Meeting to be held on Sunday, June 6, 2021, beginning at 6:00 PM local time, at the picnic pavilion at Darden-Towe Memorial Park or its alternate site, for the purposes of nominating a Republican candidate for the office of Delegate to be voted for in the General Election on November 2, 2021, and for the transaction of such other business as may properly come before the mass meeting.

Qualifications for Participation

All legal and qualified voters of the 57<sup>th</sup> House District under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions or primaries encompassing their respective election districts.

In addition to the foregoing, per the Plan of Organization, unless otherwise stipulated by the appropriate Official Committee, a person otherwise qualified hereunder shall not have participated in Virginia in the nomination process of a party other than the Republican Party within the past five years. A single exception to the preceding shall be approved for a voter that renounces affiliation with any other party in writing, and who expresses in writing that s/he is in accord with the principles of the Republican Party and intends, at the time of the writing, to support the nominees of the Republican Party in the future.

Voters may be required to produce personal identification such as a valid driver's license or voter registration card in order to participate in the mass meeting. Only those individuals who are registered (or are in line to be registered) by 6:00 PM local time on Sunday, June 6, 2021 will be entitled to participate in the Mass Meeting.

Filing Requirements

Candidates for the election or nomination at said Mass Meeting shall file a signed written statement in person, to Dan Moy (call 703-298-9497 or email [danmoy@mac.com](mailto:danmoy@mac.com) to coordinate), which must be received not later than 5:00 PM on Friday, June 4, 2021, together with a filing fee of Five Hundred Dollars (\$500). Postmarks shall not govern. Checks should be made out to the "57<sup>th</sup> LDC c/o Charlottesville Republican Committee." Only those candidates who have properly filed for the Republican nomination will be considered for nomination at the Mass Meeting; nominations from the floor will not be allowed. If only one candidate properly files, then said candidate shall be declared the Republican nominee and no Mass Meeting will be held. The mass meeting will be canceled if no candidate properly files.

Registration Fees

There will be no registration fee to participate in this mass meeting.
