

Mass Meeting of the Amherst County Committee of the Republican Party of Virginia

OFFICIAL CALL

As Chairman of the Amherst County Committee of the Republican Party of Virginia, and pursuant to the Plan of Organization and as recommended and directed by the committee, I, S. Vance Wilkins, Jr., do hereby issue this Call for a Mass Meeting to be held at the Madison Heights Community Center, 424 Woody's Lake Road, Madison Heights, Virginia 24572, beginning at 7:00 pm local time on **February 28, 2022**. Registration begins at 6:00 pm local time.

THE PURPOSE OF THE MASS MEETING is to:

- 1) Elect a Chairman for the Amherst County Republican Committee
- 2) Elect members to the Amherst County Republican Committee
- 3) Elect up to 415 Delegates and an equal number of Alternates to the Republican Party of Virginia 5th Congressional District Convention to be held on **May 21, 2022 at 10:00 am** at the Kirby Field House at Hampden-Sydney College, 198 Athletic Center Drive, Farmville, VA 23901, or an alternate site if necessary. The purpose of the Convention is: a) Election of District Committee Chairman, b) Election of Republican Nominee for U.S. House of Representatives, and c) Transaction of such other business as may properly come before the Convention. Amherst County will have 83 delegate votes.
- 4) Conduct such other business as may properly come before the Mass Meeting

QUALIFICATIONS FOR PARTICIPATION

All legal and qualified voters of Amherst County, under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin, or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its Mass Meetings, party canvasses, conventions or primaries encompassing their respective election districts.

MILITARY PROVISION

Military Members (any members of the Virginia National Guard, or the United States Armed Forces, Merchant Marine, or Coast Guard currently serving on active duty) may be certified as delegates by complying with the procedures detailed in a Unit's call pursuant to Art. VIII, Sec. H, para. 6. Military Member delegates or alternate delegates that are unable to attend the convention in person due to obligations of their official military orders, shall have their votes cast within their unit delegation according to candidate preference ballots.

Candidate preference ballots will be made available by the Fifth District Committee no later than April 16, 2022 and will be made available on the Fifth District Republican Committee website or upon request by e-mail to sabragear@gmail.com. Candidate preference ballots must be received by the Recording Secretary no later than May 11, 2022, by email to sabragear@gmail.com or by physical delivery to 250 Sunny Point Lane, Boydton, VA 23917.

REGISTRATION

For Mass Meeting registration, all participants must be registered voters in Amherst County, Virginia, and shall be required to provide proof of identity in the form of a valid government or employer-issued photo identification. **Only those individuals who are registered at the Mass Meeting by 7:00 pm local time on February 28, 2022, or who are in line for registration by that time, will be entitled to register and participate in the Mass Meeting.**

PRE-FILING REQUIREMENTS

- 1) Persons running for Delegate to the Republican Party of Virginia 5th Congressional District Convention to be held on May 21, 2022 **must submit an Official Delegate Pre-file Form** to the Committee Secretary, L R. Hoilman of the Amherst County Republican Committee. The **Official Delegate Pre-file Form** is attached to this call or can be downloaded at the Republican Party of Virginia website, (www.rpv.org), the 5th District Republican website (<https://5thdistrictva.gop>), the website of Amherst County Republican Committee, www.amherstcountyqop.org or may be obtained from L. R. Hoilman at randyhoilman331@gmail.com and Vance Wilkins at vancewilkins27@gmail.com . All official forms must be received by 5:00 pm local time on **February 18, 2022**. **Postmarks do not govern.**
- 2) All candidates running for ACRC Chairman and/or Membership must pre-file using the ACRC Pre-File Form. This form is attached to this Call or can be downloaded at the Republican Party of Virginia website, (www.rpv.org), the 5th District Republican website (<https://5thdistrictva.gop>), the website of Amherst County Republican Committee www.amherstcountyqop.org, or may be obtained from L. R. Hoilman at randyhoilman331@gmail.com . Candidates for ACRC Chairman must include a \$200 filing fee at the time they Pre-File.

ALL FORMS must be received by the Secretary no later than February 18, 2022 by 5 PM to be valid.

If in person, the Secretary, or his designee will be at 299 E Monitor Road, Amherst VA 24521 to receive last minute in person filings from **4 pm until 5 pm on February 18, 2022**.

If the number of persons pre-filing for election as Delegates to the Republican Party of Virginia 5th Congressional District Convention, and for election to all Offices or Memberships to be decided upon by the Mass Meeting does not exceed the number allowed by the Party Plan of the Republican Party of Virginia, as amended, and this Call, then they will be declared elected, and the Mass Meeting may be canceled.

There will be no registration fees required to participate in the Mass Meeting or 5th District Convention.

DISTRICT CONVENTION VOLUNTARY REGISTRATION FEE:

Every person elected as a Delegate or Alternate Delegate to the Fifth Congressional District Convention will be asked to pay a voluntary fee to help cover the Convention expenses. A \$25 voluntary fee can be paid to the Fifth District Republican Committee. Seating will be determined by the number of Delegates who are certified. Preference seating will be given based on the number of Delegates in a Unit who pay the voluntary filing fee. Delegates may pay the voluntary fee online at <http://www.5thdistrictva.gop/>.
