

# **OFFICIAL CALL**

## **Mecklenburg County Republican Committee (MCRC) Mass Meeting Of the Republican Party of Virginia**

As Chairman of the Mecklenburg County Republican Committee (MCRC), and pursuant to the Plan of Organization and as recommended and directed by the County Committee, I, R. Wallace Hudson, Chairman, do hereby issue this call for a Mass Meeting to be held at the New Hope Baptist Church Fellowship Hall located at 255 Union Mill Road, LaCrosse, VA 23950 starting at 7:00 PM local time on Tuesday, February 8, 2022, for the purpose of:

- 1) Electing a Committee Chairman
- 2) Electing members of the committee, and the following officers: Committee Vice-Chairman, a Committee Secretary, and a Committee Treasurer.
- 3) Elect up to 345 Delegates and an equal number of alternates to the 5<sup>th</sup> District Convention. The MCRC has 69 votes. The 5<sup>th</sup> District Convention will be held on May 21, 2022, in Prince Edward County at 10:00 AM at:

- (1) Electing a chairperson for the 5<sup>th</sup> District, (2) Electing a candidate to run for Congress of the United States, (3) Transaction of such other business as may properly come before the Convention.**

### **Qualifications for Participation**

All legal and qualified voters of the County of Mecklenburg under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meeting, party canvasses, conventions or primaries encompassing their respective election districts.

### **Filing Requirements**

Delegates to the 5<sup>th</sup> District Convention must file an official form which is attached to this Call and available at **5thdistrictva.gov/** These forms must be filed by mail or in person to the Chairman's address below. Committee Officer Candidates for the election or nomination at said mass meeting shall file a written statement by mail or in person to:

**All forms must be received no later than 5:00 pm on February 2, 2022. Postmarks DO NOT govern.**

Should only one candidate each file for all unit offices and no more than 345 delegates file for the 5<sup>th</sup> District Convention, then the mass meeting may be cancelled by the Chairman.
