### **Prince Edward County Republican Committee (PCRC) Call for Mass Meeting Of the Republican Party of Virginia**

As Chairman of the Prince Edward County Republican Committee (PCRC) , and pursuant to the Plan of Organization and as recommended and directed by the County Committee, Diana Shores, Chairman, do hereby issue this call for a Mass Meeting to be held March 22, 2022 starting at 7 PM local time, 45 Simpson Road, Prospect, VA 23960 for the purpose of:

- 1) Electing a Committee Chairman;
- 2) Electing members of the committee;
- 3) Elect up to 165 Delegates and an equal number of alternates to the 5<sup>th</sup> District Convention. The PCRC has 33 votes. The 5<sup>th</sup> District Convention will be held on May 21, 2022, in Prince Edward County at 10:00 AM at:

- (1) Electing a chairperson for the 5<sup>th</sup> District, (2) Electing a candidate to run for Congress of the United States, (3) Transaction of such other business as may properly come before the Convention.

#### Qualifications for Participation

All legal and qualified voters of the County of Prince Edward under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meeting, party canvasses, conventions or primaries encompassing their respective election districts.

#### Filing Requirements

Delegates to the 5<sup>th</sup> District Convention must file an official form which is attached to this Call and available at **5thdistrictva.gop/** These forms must be filed by mail, email, or in person to the Chairman's address below.
