# OFFICIAL CALL 2022 MASS MEETING OF THE CITY OF FAIRFAX REPUBLICAN PARTY

As Chairman of the City of Fairfax Republican Committee of the Republican Party, and pursuant to the plan of organization and as recommended and directed by the committee, I, Becky A. Stoeckel, do hereby issue this call for a MASS MEETING to be held at The Old Firestation #3, 3988 University Drive (upstairs), Fairfax, VA 22030 or its alternate site on **Saturday, March 26, 2022**, starting at 8:00 PM, for the following purposes:

- a) Electing a Unit Chairman;
- b) Electing up to 70 members to the City of Fairfax Republican Committee;
- c) Electing up to 150 Delegates and 150 Alternate Delegates to the 11<sup>th</sup> Congressional District convention to be held on Saturday, May 7, 2022 beginning at 10:00 AM at University of North America, 12750 Fair Lakes Circle, Fairfax, VA 22033

The purposes of the District Convention is to:

- 1) Elect a District Chairman;
- 2) For transaction of such other business as may properly come before the convention.
- d) For transaction of such other business as may properly come before the mass meeting.

Selection of the 11<sup>th</sup> District Republican nominee for Congress shall be by Party Canvass (a.k.a. Firehouse Primary) to be held on Saturday, May 7, 2022, in conjunction with the 11<sup>th</sup> District Convention, beginning at 9:00 AM and ending at 4:00 PM, at 12750 Fair Lakes Circle, Fairfax, VA 22033.

#### **QUALIFICATIONS FOR PARTICIPATION**

All legal and qualified voters of the 11th Congressional District under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party, and who, if requested, express in open meeting either orally or in writing as may be required their intent to support all of its nominees for public office in the November 8, 2022 election may, as members of the Republican Party of Virginia, be elected as delegates or alternate delegates to this Convention and participate in the Party Canvass, subject to the provisions in Article I of the Plan of Organization.

In addition to the foregoing, to be in accord with the principles of the Republican Party, a person otherwise qualified hereunder shall not have participated in Virginia in the nomination process of a party other than the Republican Party with in the last five years. A single exception shall be approved for a voter that renounces affiliation with any other party in writing, and who expresses in writing that he or she is in accord with the principles of the Republican Party and intends to support the nominees of the Republican Party in the future. A voter who utilizes the foregoing exception, and thereafter participates in the nomination process of a party other than the Republican Party, shall not have the benefit of the exception identified in this paragraph thereafter. The City of Fairfax Republican Committee will provide a copy of all signed renunciation statements to the Republican Party of Virginia, to be maintained for a period of five (5) years.

## BALLOTING

All properly registered attendees at the Mass Meeting shall be permitted to vote. Balloting shall not begin before 8:30 PM. Upon commencement of the first ballot for any office and thereafter, no quorum call or point of order regarding the quorum of the Mass Meeting or of any committee thereof shall be in order. No absentee voting, proxies, or provisional ballots are permitted.

## REGISTRATION

Mass Meeting registration shall begin at 7:30 PM and shall conclude at 8:30 PM. The Mass Meeting shall be called to order at 8:00 PM.

In order to participate in the Mass Meeting, voters must present a valid, non-expired photo identification issued by the Commonwealth of Virginia, one of its political subdivisions, or the United States government as outlined in § 24.2-643 of the Code of Virginia, at registration.

## FILING FORMS AND PREFILING REQUIREMENTS

<u>Prefiling is required</u> for those wishing to be elected as City Chairman, Delegate or Alternate Delegate to the District Convention, and/or to be elected as a member of the City Republican Committee. Prefiling to participate in the Mass Meeting is encouraged, but <u>not</u> required.

Prefiling is <u>not</u> required to participate in the Party Canvass (Firehouse Primary) to be held on May 7<sup>th</sup> to select the 11<sup>th</sup> District Republican nominee for Congress.

Official Filing Forms are available for download at <u>www.virginia.gop</u>; or you may request a copy by mail by writing to COFRC Chairman Becky Stoeckel, 10412 Main Street, Fairfax, VA 22030 or via email to <u>epi.becky@gmail.com</u>.

<u>All filing forms must be signed originals</u>. No faxed or emailed forms are acceptable. Each person must file on a separate form and all necessary fees for each separate filing must be attached to such filing. Each filing form shall have a separate personal check or money order for any applicable filing fees attached to such form. All filing forms must be reasonably legible and contain all mandatory information requested therein. All noncompliant forms shall be subject to rejection, and funds attached to such noncompliant forms shall be deemed contributions to the City of Fairfax Republican Committee.

## MILITARY MEMBERS AS DELEGATES

Military Members (any members of the Virginia National Guard, or the United States Armed Forces, Merchant Marine, or Coast Guard currently serving on active duty) who comply with these filing requirements shall not be required to be elected, but shall be declared delegates pursuant to Article VIII, Section H. of the Plan of Organization of the Republican Party of Virginia.

Military Member delegates or alternate delegates that are unable to attend the convention in person due to obligations of their official military orders, shall have their votes cast within their unit delegation according to candidate preference ballots. Instructions regarding the casting of candidate preference ballots are available in the Call for the Convention, which is available on the website of the Republican Party of Virginia (www.virginia.gop).

## FILING FOR CHAIRMAN OF THE CITY OF FAIRFAX REPUBLICAN COMMITTEE

Any person who desires to seek election as Chairman of the City of Fairfax Republican Committee must file in writing on the Official COFRC Filing Form, and include a filing fee of \$100.00 (One hundred dollars and zero cents), with the City of Fairfax Republican Committee Chairman Mrs. Becky Stoeckel, or her designee, accepting applications at 10412 Main Street, Fairfax, VA 22030, prior to **6:00 PM, Thursday, March 17, 2022** (postmark shall not count).

## FILING FOR COMMITTEE MEMBERSHIP

Candidates for Membership to the City of Fairfax Republican Committee must file in writing on the Official COFRC Filing Form and include a filing fee of \$20.00 (Twenty dollars and zero cents) with the COFRC Chairman Mrs. Becky Stoeckel, or her designee, accepting applications at 10412 Main Street, Fairfax, VA 22030, prior to **6:00 PM, Thursday, March 17, 2022** (postmark shall not count). The filing fee for Committee membership will be applied to the first year's dues for City Committee membership. Election as a committee member shall be based first on Precinct and then At-Large. No individual will be elected to more than one level of membership.

## ADDITIONAL APPLICABLE FEES

A \$10.00 (Ten dollars and zero cents) <u>voluntary</u> registration fee is requested to participate in the Mass Meeting to help defray expenses associated with the Mass Meeting.

A \$25.00 (Twenty five dollars and zero cents) filing fee is <u>mandatory</u> for each Candidate for Delegate and Alternate Delegate to the 11<sup>th</sup> Congressional District Convention to participate in the intra-party election for District Chairman.

There is NO fee required for those individuals who wish to participate <u>only</u> in the election for 11<sup>th</sup> District Republican nominee for Congress, however <u>voluntary</u> donations of \$25.00 (Twenty five dollars and zero cents) are requested to help defray expenses associated with the Party Canvass (Firehouse Primary).

<u>All</u> applicable fees <u>must</u> accompany the Official COFRC Filing Form. All payments must be made by personal check or money order, payable to the City of Fairfax Republican Committee. No company/business checks can be accepted. Cash payments can be accepted <u>only</u> when filing in person. Filing and/or registration fees are non-refundable and are not deductible as charitable contributions for income tax purposes.

## **GENERAL RULES**

The State Party Plan, the Call of the Mass Meeting, and the Rules adopted by the Mass Meeting shall take precedence in governing the Mass Meeting. Robert's Rules of Order, *Newly Revised*, shall also govern insofar as they do not conflict with the State Party Plan, the Call of the Mass Meeting, and the Mass Meeting Rules.

At the closing of the pre-filing deadline, at 6:00 PM on March 17, if fewer than the maximum number of candidates that can be elected at the Mass Meeting are filed, all properly filed candidates shall be deemed elected and <u>NO</u> Mass Meeting will be held. A notice of cancellation will be posted on the website of the Republican Party of Virginia (<u>www.rpv.org</u>) and those that filed will be notified by email.

## CITY OF FAIRFAX REPUBLICAN PARTY MASS MEETING - 2022 PRE-FILING AND REGISTRATION FORM

A City of Fairfax Republican Party Mass Meeting will be held on **Saturday, March 26, 2022** at Old Firestation #3, 3988 University Drive (upstairs), Fairfax, VA 22030, at 8:00 p.m. Sign-in will BEGIN at 7:30 p.m. and CLOSE at 8:30 p.m. Only those who properly sign in and meet the qualifications and conditions stipulated in the Call will be permitted to participate in the proceedings of the Mass Meeting.

**PREFILING REQUIREMENTS:** Prefiling is <u>required</u> of all candidates for election at the Mass Meeting, specifically: (1) Candidates for delegate to the 11th District Convention, (2) Candidates for membership in the City of Fairfax Republican Committee, and (3) Candidates for Chairman. (postmark shall not count). Prefiling to <u>participate</u> in the City of Fairfax Republican party Mass Meeting and/or the Party Canvass (Firehouse Primary) to select the 11<sup>th</sup> District Republican nominee for Congress is encouraged, but <u>not</u> required.

**Prefiling Location, Deadline, and Procedures**: Completed prefiling forms and applicable payments for candidates for election must be received no later than 6:00 p.m., March 17, 2022 by the City of Fairfax Republican Committee Chairman Mrs. Becky Stoeckel or her designee, accepting applications at 10412 Main Street, Fairfax, VA 22030 (postmark shall not count).

**Payments**: Make <u>SEPARATE</u> check or money order <u>FOR EACH PERSON</u>, payable to <u>City of Fairfax Republican Committee</u>. Payments are not tax-deductible. No company/business checks. Cash payments can be accepted only when filing in person. All fees are non-refundable.

**Prefiling Receipts**: Receipts can be provided if form is submitted in person. If you mail your form and want a receipt please include a self addressed, stamped envelope. Presentation of the prefiling receipt at sign in to the Mass Meeting will assist in demonstrating that prefiling was properly accomplished before the deadline.

**Required Affidavit**: I, the undersigned, hereby swear or affirm that I do not intend to participate in the nomination process of any party other than the Republican Party and I intend to support the Republican nominee(s) for public office for the Election to be held on Tuesday, November 8, 2022.
