



## Greene County Republican Committee

**Call for a Republican Party Canvass in Greene County to  
Elect Delegates to the Seventh Congressional District Convention,  
and to Elect Officers and Members of the Greene County Republican Committee.**

I, Steven Lee Kruskamp Jr., Chairman of the Greene County Republican Committee, pursuant to the Republican State Party Plan and as directed by the Greene County Republican Committee do hereby issue this call for a Party Canvass to be held on March 10, 2022, from 5:30 PM to 8 PM EDT at Blue Ridge Cafe 8315 Seminole Trail, Ruckersville, VA 22968 or alternate location to be determined by the chairman for the following purposes:

- (1) (A.) To elect up to 200 Delegates (or number prescribed by RPV) and an equal number of Alternate Delegates to cast 51 delegate votes at the Seventh Congressional District Republican Convention to be held on April 9, 2022, at Caroline High School, 19155 Rogers Clarke Blvd. Milford, Virginia 22514; (B.) to elect the following officer of the Greene County Republican Committee: Chairman, to two-year term, and (C.) to elect members of the Greene County Republican Committee representing their respective precincts, within the limits prescribed by the By-Laws of the Greene County Republican Committee.
- (2) The purpose of the Seventh Congressional District Convention is to elect a Republican Congressional District Chairman.

**Qualifications for Participation:** All legal and qualified voters of Greene County under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party, and who, if requested, express in public meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions, or primaries encompassing their respective election districts.

A voter who, subsequent to making a statement of intent, publicly supports a candidate in opposition to a Republican nominee shall not be qualified for participation in party actions as defined in Article I of the State Party Plan for a period of four (4) years.

In addition to the foregoing, to be in accord with the principles of the Republican Party, unless otherwise stipulated by the appropriate Official Committee, a person otherwise qualified hereunder shall not have participated in Virginia in the nomination process of a party other than the Republican Party within the last five years. A single exception to this shall be approved for a voter that renounces affiliation with any other party in writing, and who expresses in writing that he/she is in accord with the principles of the Republican Party and intends, at the time of the writing, to support the nominees of the Republican Party in the future. Any voter that utilizes the foregoing exception, and thereafter participates in the nomination process of a party other than the Republican Party, shall not have the benefit of the exception identified in this paragraph thereafter.

**Candidate Filing Requirements:** Any person wishing to file as a candidate for Delegate to the Seventh District convention and/or for membership in the Greene County Republican Committee must file a Declaration of Candidacy with Chairman Steve Kruskamp, 615 Hancock Dr. Ruckersville VA, in person or by mail, which must be received on or before 12:00 PM, March 3rd, 2022.

Anyone wishing to run as a candidate for Unit Chairman of the GCRC must file their Declaration of Candidacy no later than 12:00 PM on February 26, 2022, by hand and in person to Chuck Covington (or alternate), 461 Tower Rd. All Declarations of Candidacy must be made on a form prescribed by the Greene County Committee and available from Chairman Steve Kruskamp and other members of the Greene County Republican Committee. Forms can also be downloaded from [www.gcrpgop.com](http://www.gcrpgop.com) and [www.virginia.gop](http://www.virginia.gop). A check covering any required fees and for dues to the Greene County Committee (if seeking membership in the Committee) must accompany this form.

Any Military Member who is otherwise qualified to participate in Republican Party actions and who has filed the required form and produced at the time of filing valid military identification or other proof of active-duty status, shall be certified as a delegate to the convention(s) filed for, and shall not be required to be elected as a delegate.

**Conduct of the Canvass:** The Canvass will be conducted on March 10, 2022 from 5:30 PM - 8 PM at Blue Ridge Cafe (see address above). Rules for the conduct of the Canvass will be promulgated by the Greene County Republican Committee, and will be available on the GCRC website.

Voters offering to vote must be properly registered in Greene County, must present a government issued photographic identification document. They must also sign a statement of intent to support the Republican Party's candidates in the general election on November 8, 2022. Persons who do not meet these requirements will not be allowed to participate.

***Provisions for the filing of fewer candidates than there are positions:** If the number of candidates, qualified under Article I of the State Party Plan, who properly file for any of the offices to be elected by this canvass does not exceed the maximum number who can be elected, then that portion of the canvass will not be held and those candidates who have been certified by the Credentials Committee shall be declared elected to the positions for which they have filed. If this applies to all offices to be elected by this canvass, the canvass shall be canceled.*

**Fees for Participation by Voters:** No fee will be required of any voter in order to participate in this canvass.

Fees are required for the following:

Seventh Congressional District Convention: A delegate registration fee of \$5.00 must be included with the notification of anyone wanting to be a delegate to the Seventh District Convention.

There is a fee of \$500 for candidates filing for the office of Chairman of the GCRC.

Anyone filing to be a member of the GCRC must also include \$30.00, which equals the one year of dues.

All required fees MUST be paid at the time of pre-filing. Checks should be made out to the Greene County Republican Committee.
