

OFFICIAL CALL

Mass Meeting
Galax City Republican Committee
of the Republican Party of Virginia

As Chairman of the Galax City Republican Committee, and pursuant to the Plan of Organization and as recommended and directed by the Committee, I, Brandon R. Boyles, do hereby issue this call for a Mass Meeting to be held on April 28th, 2022 at Vaughan Furniture Office Complex, 816 Glendale Road, Galax, Virginia 24333, starting at 6:30 PM local time for the following purposes:

1. To elect a unit chairman, and members to the unit committee;
2. And for the transaction of such other business as may properly come before the mass meeting.

Qualifications for Participation

All legal and qualified voters of GALAX CITY under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions or primaries encompassing their respective election districts.

In addition to the foregoing, to be in accord with the principles of the Republican Party, unless otherwise stipulated by the appropriate Official Committee, a person otherwise qualified hereunder shall not have participated in Virginia in the nomination process of a party other than the Republican Party within the last five years.

A single exception to this shall be approved for a voter that renounces affiliation with any other party in writing, and who expresses in writing that he/she is in accord with the principles of the Republican Party and intends, at the time of this writing, to support the nominees of the Republican Party in the future. Any voter that utilizes the foregoing exception, and thereafter participates in the nomination process of a party other than the Republican Party, shall not have the benefit of the exception thereafter.

Voters may be required to produce personal identification such as a valid photo ID that is acceptable for voting purposes in order to participate.

Filing Requirements

Candidates for election for Unit Chairman and Members of the Galax Republican Committee, shall file a written statement by mail or in person, to Brandon R. Boyles, 222 Terrace Lane, Galax, Virginia 24333, which must be received not later than April 21, 2022 at 5:00 PM OR by email at boyles33@yahoo.com. Postmarks shall not govern.

Uncontested Offices/Cancellation of Mass Meeting

If no more than one candidate files for election to any office to be voted upon at the mass meeting, that candidate will be declared elected. If fewer than the maximum number of unit committee members that Galax Republican Committee has established pre-file, all properly pre-filed candidates shall be declared elected to the applicable unit committee membership position.
