OFFICIAL CALL

Mass Meeting of the Westmoreland County Committee Of the Republican Party of Virginia

As Chairman of the Westmoreland County Republican Committee of the Republican Party of Virginia, and pursuant to the Plan of Organization and as recommended and directed by the Committee, I, Alan Aylor, do hereby issue this call for a Mass Meeting to be held at the American Legion Post 252 Building, 14576 Kings Highway, Montross Virginia 22520 on Tuesday April 12, 2022 (check in to begin at 6:00 P.M.) starting at 6:30 PM for the following purposes:

- 1) Electing up to 100 members of the Unit Committee;
- 2) Electing a Unit Chairman

Qualifications for Participation

All legal and qualified voters of Westmoreland County, under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions or primaries encompassing their respective election districts.

In addition to the foregoing, to be in accord with the principles of the Republican Party, a person otherwise gualified hereunder shall not have participated in Virginia in the nomination process of a party other than the Republican Party in the last five years. A single exception to the above shall be approved for a voter that renounces affiliation with any other party in writing, and who expresses in writing that he/she is in accord with the principles of the Republican Party and intends, at the time of the writing, to support the nominees of the Republican Party in the future. A voter that utilizes the foregoing exception, and thereafter participates in the nomination process of a Party other than the Republican Party, shall not have the benefit of the exception as identified in this paragraph thereafter. In order to be eligible for election as a Delegate or Alternate Delegate to any convention, an individual must be registered to vote no later than the pre-filing deadline established by the Official Committee or, if pre-filing is not a requirement, no later than the date of election as a Delegate. A person who has made application for registration and meets all other requirements herein, but whose name does not appear on the local registration books solely because of the books having been closed in connection with a local election, will nevertheless be deemed a legal and qualified voter.

Pre-Filing Requirements

Candidates for the election of a unit chairman shall pre-file using the Westmoreland County Republican Committee pre-file form attached by mail or in person, with a registration fee of \$10.00 (non-refundable and payable to the Westmoreland County Republican Committee) to Alan Aylor, 1623 Leedstown Road, Colonial Beach, Va 22443, which must be received no later than Tuesday April 5, 2022 at 5:00 p.m. Postmarks do not govern. If only one qualified candidate properly files, then said candidate shall be declared the chairman.

Candidates for election to the positions of member of the Westmoreland County Republican Committee shall pre-file using the Westmoreland County Republican Committee pre-file form attached, with a registration/dues fee of \$10.00 (non-refundable and payable to the Westmoreland County Republican Committee) to Alan Aylor, 1623 Leedstown Road, Colonial Beach, Va 22443 which must be received no later than Tuesday April 5, 2022 at 5:00 p.m. Postmarks do not govern.

Candidates for committee membership that are current members of the Westmoreland County Republican Committee will be declared elected. Candidates that are not currently Westmoreland County Republican Committee members will be voted on at the next Westmoreland County Republican Committee meeting.

If the number of persons properly pre-filed as candidates for Committee membership to be elected at the mass meeting does not exceed the maximum number that can be elected, then all properly pre-filed qualified candidates shall be declared elected and no vote will be held. Further, if the number of persons properly pre-filed for Committee membership to be decided upon by the mass meeting does not exceed the maximum number that can be elected, the mass meeting will be canceled.
