OFFICIAL CALL

Party Canvass of the Henrico County Republican Committee of the Republican Party of Virginia

As Chairman of the Henrico County Republican Committee ("Committee") of the Republican Party of Virginia, and pursuant to the Plan of Organization and the Committee's By-Laws, and as recommended and directed by the Committee, I, Bryan W. Horn, do hereby issue this call for a Party Canvass to be held at Atlas 42, 4032 Cox Rd Suite A, Glen Allen, VA 23060, beginning at 10:00 AM local time and ending at 12:00 Noon local time on April 16, 2022 for the following purposes:

- a) Electing a Unit Chairman; and
- b) Electing up to 2,385 members of the Unit Committee.

Qualifications for Participation

All legal and qualified voters of Henrico County, Virginia under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in this Party Canvass, subject to the provisions in Article I of the RPV Plan of Organization.

Proper Identification Required

Canvass participants must present one of the forms of identification listed in § 24.2-643 of the Code of Virginia in order to participate.

Filing Requirements

Candidates for election to the membership of the Committee at said canvass shall file a written statement ("Membership Prefiling Form") and shall include a check or evidence of payment of dues for 2022 in the amount of \$30.00 payable to the Henrico County Republican Committee. Dues payment is mandatory. Dues may be paid electronically at www.henricogop.com. Dues payments made by new member applicants after December 1, 2021, shall be treated as dues for 2022.

The Membership Prefiling Form and 2022 dues/evidence of payment must be filed on or before 5:00 PM local time on April 11, 2022. The Membership Prefiling Form is attached to this Call and may be found on the electronic filing portal and may be filed as follows:

In addition to the requirements above relating to election to the membership of the Committee, candidates for election to the office of Chairman of the Committee at said canvass shall file a written statement ("Chair Prefiling Form") and shall include a filing fee of \$750.00 on or before 5:00 PM local time on March 29, 2022. The Chair Prefiling Form is attached to this Call and shall be filed in hard copy paper form in person with the Chairman by appointment only. Electronic filing of the Chair Prefiling Form is prohibited.

NOTE: EMAIL FILING OF FORMS IS NOT PERMITTED. ANY FORMS RECEIVED BY EMAIL SHALL BE DEEMED TO NOT BE PROPERLY FILED. US MAIL POSTMARKS DO NOT CONTROL. ACTUAL TIMELY ONLINE FILING OR RECEIPT REQUIRED.

Ranked Choice Voting

If more than two (2) qualified candidates file for Chairman of the Henrico County Republican Committee, the canvass will use Ranked Choice Voting.

Cancellation

If not more than the number of persons to be nominated or elected shall properly file for any office, then such properly filed persons shall be declared nominated or elected as the case may be, and no election will occur for that office. Should all elections be canceled, the Party Canvass will also be canceled. A notice of cancellation will be posted on the website of the Henrico County Republican Committee (www.henricogop.com) and on the website of the Republican Party of Virginia (www.virginia.gop).
