

OFFICIAL CALL
Party Canvass
Buchanan County Republican Committee
of the Republican Party of Virginia

As Chairman of the Buchanan County Republican Committee, and pursuant to the Plan of Organization and as recommended and directed by the Committee, I, Kim Boyd-Hibbitts, do hereby issue this call for a Party Canvass to be held at Riverview Elementary/Middle School, 27382 Riverside Drive, Grundy, VA 24614 (or its alternate site), from 5:00PM-8:00PM local time on June 21, 2022 for the following purposes:

1. To elect a unit chairman, 1st Vice Chairman, 2nd Vice Chairman, Recording Secretary, Correspondence Secretary, Treasurer, Parliamentarian, and members to the unit committee;

Qualifications for Participation

All legal and qualified voters of Buchanan County under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions or primaries encompassing their respective election districts.

In addition to the foregoing, to be in accord with the principles of the Republican Party, unless otherwise stipulated by the appropriate Official Committee, a person otherwise qualified hereunder shall not have participated in Virginia in the nomination process of a party other than the Republican Party within the last five years.

A single exception to this shall be approved for a voter that renounces affiliation with any other party in writing, and who expresses in writing that he/she is in accord with the principles of the Republican Party and intends, at the time of this writing, to support the nominees of the Republican Party in the future. Any voter that utilizes the foregoing exception, and thereafter participates in the nomination process of a party other than the Republican Party, shall not have the benefit of the exception thereafter.

Voters may be required to produce personal identification such as a valid photo ID that is acceptable for voting purposes in order to participate.

Filing Requirements

Candidates for election for Chairman, 1st Vice Chairman, 2nd Vice Chairman, Recording Secretary, Correspondence Secretary, Treasurer, Parliamentarian and members to the unit committee; at said party canvass shall file a completed pre-filing form via e-mail or in person, to Chairman Kim Boyd-Hibbitts (or authorized designee) at 1103 Plaza Drive, Suite C, Grundy,

Virginia which must be received not later than 7PM June 14, 2022 and accompanied by any fees required. Postmarks shall not govern.

There will be no filing fee for unit chairman, 1st Vice Chairman, 2nd Vice Chairman, Recording Secretary, Correspondence Secretary, Treasurer or Parliamentarian.

Uncontested Offices/Cancellation of Party Canvass

If no more than one candidate properly files for election to any office to be voted upon at the party canvass, that candidate will be declared elected. If fewer than the maximum number of unit committee members that Buchanan County Republican Committee has established pre-file, all properly pre-filed candidates shall be declared elected to the applicable unit committee membership position.
