## OFFICIAL CALL

## For a Party Canvass Buchanan County Republican Committee of the Republican Party of Virginia

As Chairman of the Buchanan County Republican Committee, and pursuant to the Plan of Organization and as recommended and directed by the Committee, I, Danny Lowe, do hereby issue this call for a Party Canvass to be held at the Grundy Plaza, 1103 Plaza Drive, Grundy, VA 24614 (or its alternate site), from 5:00 p.m. - 8:00 p.m. local time on January 19, 2023 for the following purposes:

1. To elect a unit chairman for the Republican Party of Buchanan County, Va.

## Qualifications for Participation

All legal and qualified voters of Buchanan County under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions or primaries encompassing their respective election districts.

In addition to the foregoing, to be in accord with the principles of the Republican Party, unless otherwise stipulated by the appropriate Official Committee, a person otherwise qualified hereunder shall not have participated in Virginia in the nomination process of a party other than the Republican Party within the last five years.

A single exception to this shall be approved for a voter that renounces affiliation with any other party in writing, and who expresses in writing that he/she is in accord with the principles of the Republican Party and intends, at the time of this writing, to support the nominees of the Republican Party in the future. Any voter that utilizes the forgoing exception, and thereafter participates in the nomination process of a party other than the Republican Party, shall not have the benefit of the exception thereafter.

- A photo identification (photo ID) issued by the federal government or Commonwealth of Virginia must be presented in order to receive a ballot to vote in the January 19, 2023 Buchanan County Republican Party canvass. Original document required; no copies or electronic representations accepted.
- A completed Republican Party of Virginia Statement of Intent form must be presented along with the voter's photo ID in order to receive a ballot to vote in the January 19, 2023 Buchanan County Republican Party canvass.

Filing Requirements

Postmarks shall not govern.

There will be no filing fee for those seeking the position of unit chairman.

## <u>Uncontested Offices/Cancellation of Party Canvass</u>

If no more than one candidate properly files for election to the office to be voted upon at the party canvass, that candidate will be declared elected and no canvass will be held.
