

OFFICIAL CALL
Mass Meeting
41st House of Delegates Legislative District Republican Committee
Of the Republican Party of Virginia

As Chairman of the 41st House of Delegates Legislative District, and pursuant to the Plan of Organization and as recommended and directed by the Committee, I, Todd King, do hereby issue this call for a Mass Meeting to be held at Meadowbrook Community Center, 267 Alleghany Spring Road, Shawsville, VA, 24162 or alternate location starting at 5:30 p.m. local time with registration opening 4:00 p.m. and ending at 5:30 p.m. May 4, 2023 for the following purposes:

1. Nominating a Republican candidate for Virginia General Assembly House of Delegates 41st District to be voted upon in the November 7, 2023, General Election:
2. And for the transaction of such other business as may properly come before the mass meeting.

Qualifications for Participation

All legal and qualified voters of 41st House of Delegates Legislative District under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin, or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions or primaries encompassing their respective election districts.

In addition to the foregoing, to be in accord with the principles of the Republican Party, unless otherwise stipulated by the appropriate Official Committee, a person otherwise qualified hereunder shall not have participated in Virginia in the nomination process of a party other than the Republican Party within the last five years.

A single exception to this shall be approved for a voter that renounces affiliation with any other party in writing, and who expresses in writing that he/she is in accord with the principles of the Republican Party and intends, at the time of this writing, to support the nominees of the Republican Party in the future. Any voter that utilizes the foregoing exception, and thereafter participates in the nomination process of a party other than the Republican Party, shall not have the benefit of exception thereafter.

Mass Meeting participants must present an acceptable form of photo identification to vote at the Meeting. Any person in line for the Meeting at 5:30 p.m. will be permitted to offer to vote.

The Mass Meeting shall, to the extent applicable, be governed by and conducted in accordance with the following (giving precedence as listed): the State Party Plan, Model Rules adopted by the Legislative District Committee, and otherwise in accordance with Roberts Rules of Order, Newly Revised. The 41st House of Delegates Legislative District Republican Committee shall promulgate appropriate rules for the operation and conduct of the Mass Meeting.

Filing Requirements

Candidates seeking the nomination at the Mass Meeting shall be required to file a written Declaration of Candidacy to seek the nomination and pay a filing fee in the amount of \$400.00 (Four Hundred Dollars) to be delivered to Todd King, Chairman at 129 N. Franklin Street, Christiansburg, VA. 24073. Such declaration and filing fee must be received no later than 12:00 p.m. (Noon) local time on Monday, March 27, 2023. Postmarks will not be considered. The written statement and filing fee must be received by the deadline.

The filing fee shall be made by check and payable to the Montgomery County Republican Committee (place on check memo line "Filing Fee – 41st House of Delegates District) which will serve as the fiscal agent of the 41st House of Delegates Legislative District Republican Committee for the Mass Meeting. Filing fees are non-refundable once remitted.

Registration Fees

There will be no required registration fee to participate in the Mass Meeting.

Uncontested Offices/Cancellation of Mass Meeting

If no more than one candidate properly files and is found to be qualified for election to any office to be voted upon at the mass meeting, that candidate will be declared elected. If there are no contested offices to be voted upon at the mass meeting, then no mass meeting will be held.
