

OFFICIAL CALL

Party Canvass

Dickenson Republican Committee

As Chairman of the DICKENSON COUNTY Republican Committee, and pursuant to the Plan of Organization and as recommended and directed by the Committee, I, GARY HALL,, do hereby issue this call for a Party Canvass to be held at the DICKENSON COUNTY REPUBLICAN HEADQUARTERS, from 10:00 AM TO 4:00 P.M. local time on MAY 6, 2023 for the following purposes:

1. Nominating a Republican candidates for
 - Clerk of Court
 - Sheriff
 - Commonwealth's Attorney
 - Treasurer
 - Commissioner of Revenue
 - Board of Supervisors District I
 - Board of Supervisors District II
 - Board of Supervisors District III
 - Board of Supervisors District IV
 - Board of Supervisors District V

to be voted upon in the November 7, 2023 General Election.

Qualifications for Participation

All legal and qualified voters of DICKENSON under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions or primaries encompassing their respective election districts.

In addition to the foregoing, to be in accord with the principles of the Republican Party, unless otherwise stipulated by the appropriate Official Committee, a person otherwise qualified hereunder shall not have participated in Virginia in the nomination process of a party other than the Republican Party within the last five years.

A single exception to this shall be approved for a voter that renounces affiliation with any other party in writing, and who expresses in writing that he/she is in accord with the principles of the Republican Party and intends, at the time of this writing, to support the nominees of the Republican Party in the future. Any voter that utilizes the forgoing exception, and thereafter participates in the nomination process of a party other than the Republican Party, shall not have the benefit of the exception thereafter.

Filing Requirements

Candidates for election for THE OFFICES OF CLERK OF COURT, SHERIFF, COMMONWEALTH'S ATTORNEY, TREASURER, COMMISSIONER OF REVENUE, AND BOARD OF SUPERVISORS shall file a written statement by mail or in person, to GARY HALL which must be received not later than **APRIL 15, 2023 AT 6:00 P.M.**

There are no candidacy filing fees.

Uncontested Offices/Cancellation of Party Canvass

If no more than one candidate properly files and is found to be qualified for election to any office to be voted upon at the Party Canvass, that candidate will be declared elected. If there are no contested offices to be voted upon at the Party Canvass, then no Party Canvass will be held.
