Mass Meeting of the Cumberland County Republican Committee of the Republican Party of Virginia

Mass Meeting Date - May 30, 2023
Approved-May 1, 2023

As Chair of the Cumberland County Republican Committee (CCRC) of the Republican Party of Virginia, and pursuant to the Plan of Organization and as recommended by the Committee, I, F. Glenn Mozingo, do hereby issue this call for a Mass Meeting to be held at the Center Presbyterian Church, 1542 Anderson Highway, Cumberland, VA 23040, or alternate location if necessary, starting at 7:00 PM local time, with registration from 5:30 PM to 7:00 PM on Tuesday, May 30, 2023, for the purposes of:

1. Nominating and/or endorsing candidates for the following Cumberland County offices for the November 7, 2023, General Election:
 - Clerk of the Circuit Court
 - Commonwealth's Attorney
 - Commissioner of the Revenue
 - Sheriff
 - Treasurer
 - District 1 Supervisor
 - District 2 Supervisor
 - District 3 Supervisor
 - District 4 Supervisor
 - District 5 Supervisor
 - District 1 School Board Member
 - District 2 School Board Member
 - District 3 School Board Member
 - District 4 School Board Member
 - District 5 School Board Member
 - Peter Francisco Soil & Water Conservation District Board Member(s)
2. Transacting such other business as may properly come before the Mass Meeting.

QUALIFICATIONS FOR PARTICIPATION:

All legal and qualified voters of Cumberland County under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the

ensuing election, may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions, or primaries encompassing their respective election districts. Voters wishing to participate in the Mass Meeting must be properly registered to vote in Cumberland County and shall be required to produce personal identification, such as a valid driver's license or a Commonwealth of Virginia Voter Registration Card. In addition to the foregoing, to be in accord with the principles of the Republican Party, a voter shall not have participated in the nominating process of a party other than the Republican Party within the last five years. A single exception to this requirement shall be approved for a voter who renounces affiliation with any other party in writing and who expresses in writing that he or she is in accord with the principles of the Republican Party and intends at the time of the writing to support the nominees of the Republican Party in the future.

DELEGATE FILING REQUIREMENTS:

All individuals wishing to participate in the Cumberland County Republican Mass Meeting are requested to file the CCRC Mass Meeting Delegate Pre-Filing Form (included with this call) by postal mail to F. Glenn Mozingo at P.O. Box 15, Cumberland, VA 23040, or by email to fgmozingo@verizon.net. It may also be hand delivered to F. Glenn Mozingo at 902 Anderson Highway, Cumberland, VA 23040. All forms must be received no later than May 22, 2023, at 7:00 PM. Postmarks do not govern, and there shall be no exceptions to the requirements specified. No filing fee is required.

DELEGATE CHECK IN:

The Mass Meeting check-in shall begin at 5:30 PM and shall conclude at 7:00 PM. All Delegates in line at 6:59 PM shall be allowed to check-in. Delegates will be required to present photo identification as part of the check-in process. The Mass Meeting shall be called to order at 7:00 PM or upon completion of check-in of all Delegates in line at 6:59 PM.

CANDIDATE FILING REQUIREMENTS:

Any candidate seeking nomination or endorsement to the above-named offices shall file a written CCRC Candidate Mass Meeting Filing Form (included with this call) by postal mail to F. Glenn Mozingo at P.O. Box 15, Cumberland, VA 23040, or by email to fgmozingo@verizon.net. It may also be hand delivered to F. Glenn Mozingo at 902 Anderson Highway, Cumberland, VA 23040. All forms must be received no later than May 25, 2023, at 7:00 PM. Postmarks do not govern, and there shall be no exceptions to the requirements specified. No filing fee is required.

It is the responsibility of the candidate to confirm receipt of his or her Candidate Mass Meeting Filing Form with the CCRC Chair, F. Glenn Mozingo at 804.912.5786.

Should only one candidate properly file and be qualified for the Republican nomination or endorsement for any elected office, then such candidate shall be deemed elected and the Mass Meeting for that office shall be cancelled. If only one candidate properly files and qualifies for

the Republican nomination or endorsement for each elected office, such candidates shall be deemed elected and the Mass Meeting shall be cancelled.

All candidates for nomination or endorsement must have filed the following forms with the Cumberland County Registrar no later than May 25, 2023, and provide copies with the Candidate Mass Meeting Filing Form.

1. Certificate of Candidate Qualification
2. Statement of Economic Interest
3. Statement of Organization (Campaign Finance Disclosures)

CONDUCT OF THE MASS MEETING:

The meeting will be conducted in accordance with the Republican Party of Virginia Party Plan, this Call, and Robert's Rules of Order Newly Revised, Twelfth Edition, in that order of precedence. District-specific office nominations and endorsements will be determined by participants attending within a given Electoral District. Nominations from the floor for these offices will not be accepted.

RESOLUTIONS:

Resolutions shall not be considered at this Mass Meeting.

MASS MEETING COMMITTEES:

The CCRC Chair shall appoint the chair and members of a Credentials Committee, Nominating Committee, and Rules Committee.

CALL REVISIONS

The Cumberland County Republican Committee is authorized to revise the issued Call to make any technical or conforming changes in the event such changes are necessary and shall promptly notify the Republican Party of Virginia.
