GENERAL OPENING

Four proxies were submitted to the Proxy Committee and approved. The secretary called the roll. 23 voting members were present constituting a quorum and a 2/3rd majority. Chairman Ryer laid out the rules of the appeals process including time restraints and format. The rules of the procedure were accepted.

APPEAL

An Appeal was heard for Mr. Moren's removal from the King William GOP Committee.

Mrs. Robinson: Gave her reasoning for the plea to be rejected.

Several members of the 1st district committee asked questions involving procedures and rules of the King William GOP Committee as well as the incidents leading up to Mr. Moren's removal from the King William GOP.

A motion was made by Pat Dunnington to uphold the decision of the King William GOP Committee in removing Ed Moren from their membership. Alan Aylor seconded the motion. David Botkins asked a question relating to the possible results of what motion is decided. Several members of the committee made comments on the appeal. The motion was carried in a voice vote.
