

**OFFICIAL CALL**  
**Party Canvass of Chesterfield County Republican Committee**  
**of the Republican Party of Virginia**

As Chairman of the Chesterfield County Committee of the Republican Party, and pursuant to the Plan of Organization and as recommended and directed by the Committee, I, Leslie Haley, do hereby issue this call for a Party Canvass to be held at **Swift Creek Middle School, 3700 Old Hundred Rd S, Midlothian, VA 23112**, from **5:30 pm to 7:30 pm** local time on **March 19, 2024**, for the following purposes:

- a) Electing a Unit Chairman and executive officers(VC Organization, Special Projects, and Finance, Recording Secretary, Treasurer and Corresponding Secretary);
- b) Electing up to 3,600 members of the Unit Committee
- c) Election of Delegates to the 1st and 4th Congressional District Conventions as listed below:

**1st Congressional District Convention:**

To elect up to 1,620 Delegates and an equal number of Alternate Delegates to the District Convention of the 1st Congressional District of the Republican Party of Virginia to be held at **King William High School, 80 Cavalier Dr, King William, VA 23086-3657, or its alternate site, starting at 10:00 a.m.** local time, with registration beginning at 8:00 a.m. local time, on **Saturday, May 4, 2024**, for the following purposes:

- 1) Electing a District Chairman of the Republican Party;
- 2) Electing three (3) Members of the State Central Committee of the Republican Party of Virginia;
- 3) Electing a Republican candidate for Elector for President and Vice President of the United States for the election to be held on November 5, 2024; and
- 4) For the transaction of such other business as may properly come before the convention.

The District Convention comprises delegates and alternate delegates based on a percentage of the total number of Republican votes cast in each county and city in the last gubernatorial and presidential elections combined. The maximum number of delegates for each unit is up to five times its respective Delegate Vote. The maximum number of delegates and alternate delegates allowed for Chesterfield County is 3,400. If you want to be a delegate, follow the pre-filing instructions and submit the form with the specified filing fee. Candidates for the Chairman, Members of the State Central Committee, and Elector positions should submit their candidate declarations and fees in writing directly to the 1st Congressional District Republican Committee. **4th Congressional District Convention:**

To elect up to 1,980 Delegates and an equal number of Alternate Delegates to the District Convention of the 4th Congressional District of the Republican Party of Virginia to be held at **Life Christian Academy, 1221 Boulevard, Colonial Heights, VA 23834, or its alternate site, starting at 11:00 a.m. local time**, with registration beginning at 10:00 a.m. local time, on **Saturday, May 4, 2024**, for the following purposes:

- 1) Electing a District Chairman of the Republican Party;
- 2) Electing three (3) Members of the State Central Committee of the Republican Party of Virginia;
- 3) Electing a Republican candidate for Elector for President and Vice President of the United States for the election to be held on November 5, 2024; and
- 4) For the transaction of such other business as may properly come before the convention.

The District Convention comprises delegates and alternate delegates based on a percentage of the total number of Republican votes cast in each county and city in the last gubernatorial and presidential elections combined. The maximum number of delegates for each unit is up to five times its respective Delegate Vote. The maximum

number of delegates and alternate delegates allowed for Chesterfield County is 3,960. If you want to be a delegate, follow the pre-filing instructions and submit the form with the specified filing fee. Candidates for the Chairman, Members of the State Central Committee, and Elector positions should submit their candidate declarations and fees in writing directly to the 4th Congressional District Republican Committee. d) Electing up to 3,600 Delegates and an equal number of Alternate Delegates to the **Republican Party of Virginia 2024 Quadrennial Convention**, to be held on **May 31 and June 1, 2024**, at the Hampton Roads Convention Center, 1610 Coliseum Drive, Hampton, VA 23666 for the following purposes:

- 1) Selecting two Electors at large to be voted for in the presidential election on November 5, 2024;
- 2) Electing a State Chairman;
- 3) Nominating a National Committeeman and National Committeewoman;
- 4) and for the transaction of such other business as may properly come before the Convention.

The State Convention is on **May 31, 2024, at 2:30 p.m.** to elect officers and adopt rules. The election is on June 1, 2024, at 10:00 a.m. Delegates and alternate delegates will represent units based on Republican votes in each county and city in the last gubernatorial and presidential elections. Each unit has at least one (1) Delegate Vote and its maximum number of delegates can go up to five (5) times its corresponding Delegate Vote. Follow the instructions on page 3 to file as a delegate from Chesterfield County and submit the form on page 4 with the filing fee. Find the Official Call for this Convention online.

### **Qualifications for Participation**

All legal and qualified voters of Chesterfield County under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin, or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia (RPV) in the Chesterfield County Republican Party Canvass and/or the 1st or 4th District Conventions and/or the RPV 2024 Quadrennial Convention subject to the provisions in **Article I and Article VII section C of the RPV Plan of Organization**. In addition to the foregoing, to be in accord with the principles of the Republican Party, unless otherwise stipulated by the appropriate Official Committee, a person otherwise qualified hereunder shall not have participated in Virginia in the nomination process of a party other than the Republican Party within the last five years. A single exception shall be approved for a voter who renounces affiliation with any other party in writing and who expresses in writing that he/she is in accord with the principles of the Republican Party and intends, at the time of the writing, to support the nominees of the Republican Party in the future. Any voter that utilizes the foregoing exception and thereafter participates in the nomination process of a party other than the Republican Party shall not have the benefit of the exception thereafter. Party Canvass voters must present one of the forms of identification listed in Title 24.2-643 of the Code of Virginia to participate.

The First and Fourth Congressional districts and the RPV State Convention adhere to the participation guidelines specified in the Republican Party of Virginia Plan of Organization for Military Members. **Filing Requirements for Chesterfield County Republican Committee Unit Chairman and Officers**

Candidates for Chesterfield County Republican Committee officers must submit a written statement of intent and fees to Carey Allen at 5939 E Stonepath Garden Dr, Chester, VA 23831. Filing fees are **\$500** for Unit Chairman and **\$100** for all other officers. Payment by check (in person or by mail) or cash (in-person only). The statement of intent and fees must be received no later than **Tuesday, January 30, 2024, at 5:00 PM local time**. Postmarks shall not govern.

**Filing Requirements for Chesterfield County Republican Committee Unit Members**

Candidates for Membership in the Chesterfield County Republican Committee must submit the official filing form (see page 4), dues, and fees (\$35) to Vice Chairman of Organization Carey Allen at 5939 E Stonepath Garden Dr, Chester, VA 23831 to be received no later than **5 PM on Wednesday, February 28, 2024**. Payment can be made by check payable to "CCRC" or cash (only if delivered in person). Postmarks shall not govern.

**Filing Requirements for Convention Delegates**

Candidates for Delegate or Alternate Delegate representing Chesterfield County at the 1st or 4th Congressional District Conventions and/or the RPV 2024 Quadrennial Convention must submit the Official Chesterfield County Republican Party Canvass Pre-File Form (see page 4) along with the appropriate filing fee(s) to the Vice Chairman of Organization, Chesterfield County Republican Committee, **Carey Allen at 5939 E. Stonepath Garden Dr, Chester, VA 23831**. The filing fees vary depending on which convention you are filing for - \$10.00 for the 1st District Convention, \$20 for the 4th District Convention, and \$45.00 for the State Convention - and should be made payable to "CCRC." Please note that the filing fees and Form (on page 4) must be received no later than **Wednesday, February 28, 2024, at 5:00 p.m. local time**. Postmarks shall not govern.

**Cancellation**

If the number of candidates, qualified under Article I of the State Party Plan, who properly file for any of the offices to be elected by this canvass does not exceed the maximum number who can be elected, then that portion of the canvass will not be held and those candidates who have been certified by the Credentials Committee shall be declared elected to the positions for which they have filed. If this applies to all offices to be elected by this canvass, the canvass shall be canceled. A cancellation notice will be posted on the Republican Party of Virginia website, [www.virginia.gop/event](http://www.virginia.gop/event).

**Publication**

Publication of this Official Call shall be posted on the website of the Republican Party of Virginia [www.virginia.gop](http://www.virginia.gop) and the website of the Chesterfield County Republican Committee [www.chesterfieldgop.com](http://www.chesterfieldgop.com).

**Call Revisions**

If necessary, the unit's chairman may modify the Call that was issued to include any technical or conforming changes and is required to notify the Unit Committee of such changes promptly.

**Registration Fee**

There will be no registration fee to participate in this canvass.

Attached is a check for the mandatory Delegate Fee of **\$10.00**. (Note: Only residents of the 1st District are eligible to be Delegates.)

I hereby seek election as a **Delegate** representing Chesterfield County at the **Fourth Congressional District Convention** to be held on Saturday, May 4, 2024, in Colonial Heights, VA. Attached is a check for the mandatory Delegate Fee of **\$20.00**. (Note: Only residents of the 4<sup>th</sup> District are eligible to be Delegates.)

I hereby seek election as a **Delegate** representing Chesterfield County at the **Republican Party of Virginia Convention** to be held on Saturday, June 1, 2024, in Hampton, VA. Attached is a check for the mandatory Delegate Fee of **\$45.00**.

**PLEASE NOTE:** Article VII, Section C of the Republican Party of Virginia's *Plan of Organization* states the following about membership on a county committee:

**A member of an Official Committee is held to a higher standard of support for nominees of the Republican Party than an individual who merely participates in a mass meeting, party canvass, convention, or primary. Therefore, a member of an Official Committee is deemed to have resigned his Committee position if he (a) makes a reportable contribution to and/or (b) allows his name to be publicly used by and/or (c) makes a written or other public statement in support of a candidate in opposition to a Republican nominee in a Virginia General or Special Election.**

I confirm that I am a registered voter in Chesterfield County. I pledge to support all Republican Party nominees during this election and my two-year term in the Chesterfield County Republican Committee. I have read and understood all requirements, including Article 1 and Article VII Section C of the RPV State Party Plan of Organization, which states in part:

**A voter who, subsequent to making a statement of intent, publicly supports a candidate in opposition to a Republican nominee shall not be qualified for participation in party actions as defined in Article I for a period of four (4) years.**
