

**OFFICIAL CALL**  
Party Mass meeting  
Madison County Republican Party

As Chairman of the Madison County Republican Party of the Republican Party of Virginia, and pursuant to the Plan of Organization and as recommended by the Committee, I, Anthony W. Jewett, do hereby issue this call for a mass meeting of the Madison County Republican Committee to be held at War Memorial, General District Court, 2 Main Street, Madison, Virginia 22727 (or alternate site if needed) at 7:00 p.m on February 28<sup>th</sup> For the following purposes:

1. Electing a Chairman of the Madison County Republican committee for a term of two years.
2. Electing the Members of the Madison County Republican committee
3. Electing up to two hundred (200) delegates and up to 200 alternate delegates to the 7<sup>th</sup> Congressional District Convention on March 23, 2024 (7th-District-Draft-Call-2024-v5-CLEAN.pdf (virginia.gop)). These delegates will:
  - a. Elect a Chairman for the 7<sup>th</sup> Congressional District
  - b. Elect three (3) State Central Committee members from the 7<sup>th</sup> Congressional District
  - c. Nominate one (1) elector for the November 5<sup>th</sup> , 2024 Presidential Election
4. Elect up to two hundred (200) delegates and up to 200 alternate delegates to the RPV State Convention on May 31-Jun 1, 2024
  - a. Elect a Chairman, National Committeeman, and National Committeewoman for the Republican Party of Virginia.
  - b. Nominate two (2) electors for the November 5<sup>th</sup>, 2024 Presidential Election

**Qualifications for Participation**

All legal and qualified voters of Madison County under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions or primaries encompassing their respective election districts.

**Filing Requirements**

Those wishing to serve as Committee chair or as delegates to the State and/or District Convention shall file the form attached to this Call, which must be received no later than **5:00 p.m., February 21st, 2024**. Postmarks, or other proof of posting or dispatch, shall not govern.

Pursuant to Art. VII and Art. XII of the Party Plan, if the limit of delegates is not exceeded and no more than a single person files to be local party chair, all individuals who qualify under Art. I will be declared elected and no mass meeting, party canvass or convention will be held to elect delegates.

**Registration Fee**

There will be no registration fee to participate in this mass meeting, however there is a registration fee of \$45 to participate in the Republican State Convention and a \$5 voluntary registration fee to participate in the 7th District Convention.

**Publication**

This call will be published at the RPV website <https://virginia.gop/>. The Unit Committee has eliminated the requirement to publish this call in a newspaper of general circulation by a two-thirds vote.

Paragraph 2, Article I-A voter who, subsequent to making a statement of intent, publicly supports a candidate in opposition to a Republican nominee shall not be qualified for participation in party actions as defined in Article I for a period of four years.

Paragraph 4, Article I-In addition to the foregoing, to be in accord with the principles of the Republican Party, unless otherwise stipulated by the appropriate Official Committee, a person otherwise qualified hereunder shall not have participated in Virginia in the nomination process of a party other than the Republican Party with in the last five years.

Paragraph 5 Article I-A single exception to Paragraph 4 shall be approved for a voter that renounces affiliation with any other party in writing, and who expresses in writing that he/she is in accord with the principles of the Republican Party and intends, at the time of the writing, to support the nominees of the Republican Party in the future. Any voter that utilizes the foregoing exception, and thereafter participates in the nomination process of a party other than the Republican Party, shall not have the benefit of the exception identified in this paragraph thereafter. Within 30 days of receipt, the Official Committee shall provide a copy of this signed renunciation statement to the Republican Party of Virginia, to be maintained for a period of 5 years.

Article VII, Section C of the Republican Party Plan of Organization states the following about membership on a county committee: A member of an Official Committee is held to a higher standard of support for nominees of the Republican Party than an individual who merely participates in a Mass Meeting, party canvass, convention or primary. Therefore, a member of an Official Committee is deemed to have resigned his Committee position if he (a) makes a reportable contribution to and/or (b) allows his name to be publicly used by and/or (c) makes a written or other public statement in support of a candidate in opposition to a Republican nominee in a Virginia General or Special Election.
