OFFICIAL CALL for a Mass Meeting of the Halifax County Republican Committee

As Chairman of the Halifax County Republican Committee of the Republican Party of Virginia, and pursuant to the “Republican Party of Virginia Plan of Organization” (hereinafter referred to as the “State Party Plan”) and as recommended and directed by the Committee, I, Andrew D. Ferguson, do hereby issue this call for a Mass Meeting of the Halifax County Republican Committee of the Republican Party of Virginia to be held at the Cluster Springs Volunteer Fire Department (1009 Black Walnut Church Road, Alton, Virginia 24520), or alternate location, with registration beginning at 5:45 p.m. and the meeting coming to order at 7:00 p.m. local time on Friday, March 8, 2024 for the following purposes:

- a) Electing a Halifax Committee Chairman;
- b) Electing up to 76 total members of the Halifax County Republican Committee of the Republican Party of Virginia as provided for in the “State Party Plan” and the “Halifax County Republican Committee Plan of Organization”.
- c) Electing up to 380 Delegates and an equal number of Alternates to the 5th Congressional District Convention, to be held on the 27th of April 2024 at the Drakes Branch Volunteer Fire Department (4801 Drakes Main Street, Drakes Branch, Virginia 23937), or alternate date and location, beginning at 10:00am for the following purposes:
 - 1) Election of a District Committee Chairman
 - 2) Election of 3 State Central Committee Members:
 - 3) Election of 1 Elector for the 2024 Presidential Election:
 - 4) Transaction of such other business as may properly come before the Convention.
- d) Electing up to 380 Delegates and an equal number of Alternates to the Republican Party of Virginia’s Statewide Convention, to be held May 31st-June 1st, 2024 at the Hampton Roads Convention Center (1610 Coliseum Drive, Hampton Virginia 23666) beginning at 2:30 p.m. on Friday and reconvening at 10:00 a.m. on Saturday:
 - 1) Nominating two Electors At-Large to cast ballots in the electoral college in the presidential election on November 5, 2024;
 - 2) Electing a State Chairman;
 - 3) Nominating a National Committeeman and National Committeewoman;
 - 4) And for the transaction of such other business as may properly come before the Convention.
- e) and for the transaction of such other business as may properly come before the mass meeting.

Qualifications for Participation

All legal and qualified voters of Halifax County under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who express in writing (by signing the pledge) their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions, or primaries encompassing their respective election districts.

Otherwise Qualified Military Members who declare via electronic mail to the local Chairman, as specified in the Call for the Convention, that because of the obligations of their official military orders, they are unable to attend their respective Unit mass meeting, canvass or convention called for the purpose of selecting delegates to a Convention, and that in lieu of selecting delegates to represent them from their respective Unit they instead wish to be represented by the Military Delegation, shall be entitled to representation via the Military Delegation.

Filing Requirements

The filing requirements shall be as follows:

- a) Candidates for the position of Committee Chairman by said mass meeting shall pre-file the approved form attached to this call (or available by request to the Chairman at (434) 579-3202 at, or after, the date of publication) along with the one-hundred fifty dollar (\$150.00) filing fee (checks payable to the Halifax County Republican Committee) in person, to Chairman Ferguson at 10148 L.P. Bailey Memorial Highway, Wednesday February 28th, 2024 between the hours of 4 and 5:00 p.m, or by pre-arranged appointment. No pre-files shall be received after 5:00 p.m. on February 28th, 2024, nor will any improperly filled forms and/or forms not accompanying the said filing fee, be considered valid.
- b) Candidates for election to the Halifax County Republican Committee by said mass meeting shall pre-file the approved form, attached to this call, and pay the twenty dollars (\$20.00) non-refundable filing fee (checks payable to the Halifax County Republican Committee) by mail to Vice-Chairman Snead at P.O. Box 130, Scottsburg, Virginia 24589, or in person at 3166 South Terry's Bridge Road, Scottsburg, Virginia Monday – Friday between the hours of 1:00 p.m. and 4:00pm by no later than 5:00 p.m. on Wednesday, February the 28th, 2024. Postmarks shall not govern, nor will late, incomplete, and/or forms not accompanying the said filing fee be considered valid.
- c) Candidates for election as Delegate to the 5th Congressional District Republican Convention by said mass meeting may pre-file the approved form attached to this call with the accompanying twenty dollar (\$20.00) registration fee (checks payable to the Halifax County Republican Committee) by mail to Vice-Chairman Snead at P.O. Box 130, Scottsburg, Virginia 24589, or in person at 3166 South Terry's Bridge Road, Scottsburg, Virginia Monday – Friday between the hours of 1:00 p.m. and 4:00 p.m. by no later than 5:00 p.m. on Wednesday, February 28th, 2024. Postmarks shall not govern, nor will late, incomplete, and/or forms not accompanying the said filing fee be considered valid. Candidates may also file during registration for the said mass meeting.
- d) Candidates for election as Delegate to the Republican Party of Virginia's Statewide Convention by said mass meeting may pre-file the approved form attached to this call with the accompanying forty-five dollar (\$45.00) registration fee (checks payable to the Republican Party of Virginia) by mail to Vice-Chairman Snead at P.O. Box 130, Scottsburg, Virginia 24589, or in person at 3166 South Terry's Bridge Road, Scottsburg, Virginia Monday – Friday between the hours of 1:00 p.m. and 4:00 p.m. by no later than 5:00 p.m. on Wednesday, February 28th, 2024. Postmarks shall not govern, nor will late,

incomplete, and/or forms not accompanying the said filing fee be considered valid. Candidates may also file during registration for the said mass meeting.

- e) Otherwise Qualified Military Members who wish to be represented by the Military Delegation shall send an electronic mail (E-mail) declaration which shall include (or be attached) a signed statement of intent to support all Republican Nominees in the General Election, an affirmation of their official military orders precluding their attendance, and their electronic mail address for correspondence. The declaration shall be emailed to Vice-Chairman Snead at krsnead2@gmail.com, with "2024 Halifax Military Delegation" in the subject line, by no later than 5:00 p.m. on Wednesday, February 28th, 2024. Subsequent to the receipt of the Declaration, Qualifying Military Members will be sent a Ballot Preference Form to be returned by email, as directed, prior to the Convention. Timestamp of the Email shall govern, and it shall be the responsibility of the applicant to confirm receipt prior to the deadline by call or text to (434) 579-6085.

Registration

Registration will begin at 5:45 p.m. and participants must be in line by 7:00 p.m. to participate. Qualified participants will be given proof of registration and they shall be required to provide such proof upon request by the meeting chairperson or their representatives. There will be no fee to participate in this mass meeting.
