OFFICIAL CALL

Mass Meeting of the Cumberland County Republican Committee of the Republican Party of Virginia

Mass Meeting Date – March 4, 2024 Approved-February 5, 2024

As Chair of the Cumberland County Republican Committee (CCRC) of the Republican Party of Virginia, and pursuant to the Plan of Organization and as recommended by the Committee, I, Glenn Mozingo, do hereby issue this call for a Mass Meeting to be held at Center Presbyterian Church, 1542 Anderson Highway, Cumberland, VA 23040, or alternate location if necessary, starting at 7:00 PM local time, with registration from 5:30 PM to 7:00 PM on Monday, March 4, 2024, for the following purposes.

- Election of a Unit Chair for the Cumberland County Republican Committee. Each person filing to be a candidate for the position of Unit Chair will pay a filing fee of \$100. The fee is payable to the Cumberland County Republican Committee.
- 2. Election of not more than 38 members of the Cumberland County Republican Committee not to exceed the following number per district. The dues payable by Committee members are \$20 and must be paid to the Cumberland County Republican Committee by July 1 of each year to remain in good standing.
 - District 101-8 members
 - District 201-6 members
 - District 301-4 members
 - District 401-5 members
 - District 501-6 members
 - CAP/At Large-9 members
- 3. Election of not more than 115 Delegates and an equal number of Alternates to the Republican Party of Virginia Fifth Congressional District Convention to be held on Saturday, April 27, 2024, at Drakes Branch Volunteer Fire Department, 4801 Drakes Main Street, Drakes Branch, VA 23937 or an alternate location if necessary for the following purposes.
 - Election of Fifth District Republican Committee Chairman;
 - Election of three (3) State Central Committee Members;
 - Election of one (1) Elector for the 2024 Presidential Election;
 - Transaction of such other business as may properly come before the Convention.

Cumberland County will have 23 delegate votes. Each person elected as a Delegate or Alternate Delegate to the Fifth Congressional District Convention will be required to pay a \$20 registration fee. Registration fees will be made payable to the Cumberland County Republican Committee.

- 4. Elect not more than 115 Delegates and an equal number of Alternates to the Republican Party of Virginia 2024 Quadrennial Convention to be held at the Hampton Roads Convention Center, 1610 Coliseum Drive, Hampton, VA 23666 on May 31 and June 1, 2024 for the following purposes.
 - Selecting two Electors At-Large to be voted for in the Presidential election on November 5, 2024;
 - Electing a State Chairman;
 - Nominating a National Committeeman and National Committeewoman;
 - and for the transaction of such other business which may come before the convention.

Cumberland County will have 23 delegate votes. Each person elected as a Delegate or Alternate Delegate will be required to pay a \$45 registration fee. Fees will

be made payable to the Cumberland County Republican Committee.

5. Transaction of such other business which may come before the Mass Meeting.

QUALIFICATIONS FOR PARTICIPATION:

All legal and qualified voters of Cumberland County under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions, or primaries encompassing their respective election districts. Voters wishing to participate in the Mass Meeting must be properly registered to vote in Cumberland County and shall be required to produce photo identification, such as a valid driver's license. In addition to the foregoing, to be in accord with the principles of the Republican Party, a voter shall not have participated in the nominating process of a party other than the Republican Party within the last five years. A single exception to this requirement shall be approved for a voter who renounces affiliation with any other party in writing and who expresses in writing that he or she is in accord with the principles of the Republican Party and intends at the time of the writing to support the nominees of the Republican Party in the future.

MILITARY MEMBERS AS DELEGATES:

Military Members (any members of the Virginia National Guard, or the United States Armed Forces, Merchant Marine, or Coast Guard currently serving on active duty) may be certified as delegates by complying with the procedures detailed in this call pursuant to Art. VIII, Sec. H, para. 6. Military Member delegates that are unable to attend the Mass Meeting in person due to obligations of their official military orders, shall have their votes cast according to candidate preference ballots.

Candidate preference ballots can be secured by contacting Glenn Mozingo by email at fgmozingo@verizon.net beginning February 21, 2024. Completed candidate preference ballots must be received by Glenn Mozingo no later than 6 pm on February 28, 2024, by return email to fgmozingo@verizon.net or by postal mail to P.O. Box 15, Cumberland, VA 23040. Postmarks do not govern.

DELEGATE FILING REQUIREMENTS:

All individuals wishing to participate in the Cumberland County Republican Committee Mass Meeting are required to file the CCRC Mass Meeting Pre-File Form (included with this call) by postal mail to F. Glenn Mozingo at P.O. Box 15, Cumberland, VA 23040, or by email to fgmozingo@verizon.net. All forms must be received no later than February 19, 2024, at 6:00 PM. Postmarks do not govern, and there shall be no exceptions to the requirements specified. No filing fee is required.

DELEGATE CHECK IN:

The Mass Meeting check-in shall begin at 5:30 PM and shall conclude at 7:00 PM. All Delegates in line at 6:59 PM shall be allowed to check-in. Delegates will be required to present photo identification as part of the check-in process. The Mass Meeting shall be called to order at 7:00 PM or upon completion of check-in of all Delegates in line at 6:59 PM.

CONDUCT OF THE MASS MEETING:

The meeting will be conducted in accordance with the Republican Party of Virginia Party Plan, this Call, and Robert's Rules of Order Newly Revised, Twelfth Edition, in that order of precedence. Nominations from the floor will not be accepted.

RESOLUTIONS:

Resolutions will not be considered during the Mass Meeting.

MASS MEETING COMMITTEES:

The CCRC Chair shall appoint the chair and members of a Credentials Committee, Nominating Committee, and Rules Committee.

MEETING CANCELLATION

In the event only one candidate files for the position of unit chair; no more than thirty-eight (38) candidates file for Committee membership; and the number of individuals filing to be delegates at the District and State conventions do not exceed the numbers allowed at each, then all will be deemed duly elected and the meeting cancelled.

CALL REVISIONS:

The Cumberland County Republican Committee is authorized to revise the issued Call to make any technical or conforming changes in the event such changes are necessary and shall promptly notify the Republican Party of Virginia.

PUBLICATION:

This Call shall be posted on the websites of the Republican Party of Virginia (https://virginia.gop/events/category/official-call/) and the Virginia Fifth Congressional District Republican Committee (Mass Meetings – Virginia 5th District GOP (5thdistrictva.gop)).
