



# Official Mass Meeting Call

## of Sussex County VA Republican Committee of the Republican Party of Virginia

As Chairman of the Sussex County Committee of the Republican Party of Virginia, and pursuant to the Plan of Organization and as recommended and directed by the Committee, I, Paul Daniel Spurlock, do hereby issue the call for a Mass Meeting to be held at the **Wakefield Municipal Airport**, 10248 General Mahone Hwy, Wakefield, VA 23888, starting at 7 p.m. local time on **March 12, 2024**, for the following purposes:

1. **Electing a Chairman, Vice Chairman, Secretary, and Treasurer for the Sussex County Republican Committee.**
2. **Electing the members of the Sussex County Republican Committee.**
3. **Electing Delegates to the 4th District Convention on May 4, 2024 in Colonial Heights, VA**
4. **Electing Delegates to the RPV State Convention on May 31 - June 1 in Hampton, VA**
5. **The transaction of other business as may properly come before the Convention.**

### Qualifications for Participation

All legal and qualified voters of Sussex County under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin, or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions or primaries encompassing their respective election districts.

### Filing Requirements for Sussex County Executive Officers

Candidates for Election as Unit Chairman, Vice Chairman, Secretary, and Treasurer shall file a written statement, in person, at the **Wakefield Municipal Airport**, 10248 General Mahone Hwy, Wakefield, VA 23888, during our February 13<sup>th</sup> meeting or email to the chairman at [sussexcountyvagop@gmail.com](mailto:sussexcountyvagop@gmail.com) or by mail to 446 Carpenter Dr. Waverly, VA 23890 before the start of the mass meeting.

**Filing Requirements for Sussex County Committee Membership  
or as Delegates or Alternate Delegates to Conventions**

To join the Sussex County Republican Committee or become a delegate/alternate delegate to the Republican Party of Virginia State Convention and/or the Fourth Congressional District Republican Convention, fill out the form on page 3 of this Mass Meeting call and submit it to the chairman at sussexcountyvagop@gmail.com or by mail to 446 Carpenter Dr. Waverly, VA 23890 before the mass meeting starts. Committee membership dues are \$10, and Convention fees are \$20 per delegate for the 4th District Convention and \$45 for the RPV State Convention.

**Registration Fees for Mass Meeting & Convention(s)**

**Mass Meeting:** Registration for the mass meeting will commence before the meeting and end at the beginning of the meeting. No registration fee is required.

**4th District Convention:** Registration fee of \$20/delegate or alternate delegate for Fourth Congressional District Republican Convention. Payment is due when filing for election as Delegate. Payable by check to Sussex County Republican Committee. The fee will be forwarded to the 4th Congressional District Republican Committee. Only paying delegates can participate. Fill out the form on Page 3 of this call.

**RPV Convention:** Delegates and alternate delegates for the Republican Party of Virginia State Convention must pay a \$45.00 registration fee when filing for election as Delegate. Payment should be made to the Sussex County Republican Committee. The fee will be forwarded to the RPV. Only registered delegates can participate. Please fill out the form on Page 3 of this official call.

**Active-Duty Military**

Any Military Member who is otherwise qualified to participate in Republican Party actions and who has filed the required form and produced at the time of filing valid military identification or other proof of active-duty status, shall be certified as a delegate to the convention(s) files for and shall not be required to be elected as a delegate.

**Registration Fees**

No fee is required to participate in the Sussex County Republican Committee Mass Meeting.
