



Floyd County Republican Committee OFFICIAL CALL FOR MASS MEETING

of the Floyd County Unit of the Republican Party of Virginia
Monday, March 25th, 2024

As chairman and pursuant to the Plan of Organization and as recommended and directed by the Committee, I, David Whitaker, do hereby issue this call for a Mass Meeting to be held at the Jessie Peterman library, 321 W. Main St. Floyd, VA. 24091, or its alternate site, starting at 6:30 p.m. on Monday, March 25th, 2024 for the following purposes:

1. Electing a unit chairman, 1st vice chairman, 2nd vice chairman, treasurer, secretary, general counsel and members to the unit committee.
2. Electing up to (175) Delegates and an equal number of Alternates to the RPV State Convention to be held on May 31 - June 1, 2024 at Hampton Roads Convention Center, 1610 Coliseum Dr. Hampton Va. 23666, or its alternate site, Convening at 2:30 p.m. on Friday, May 31 and 10 a.m. on Saturday June 1st for the following purposes:
 - A. Electing a State Chairman
 - B. Electing a National Committeeman and National Committeewoman
 - C. Nominating two Electors At-Large to serve in the 2024 Electoral College, and
 - D. And for the transaction of such other business as may properly come before the convention.

QUALIFICATIONS FOR PARTICIPATION

All legal and qualified voters of Floyd County, under the laws of the commonwealth of Virginia, regardless of race, religion, national origin, or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all if its nominees for public office in the upcoming election, may participate as members of the Republican party of Virginia in its mass meetings, party canvasses, conventions or primaries encompassing their respective election districts. In addition to the foregoing, to be in accord with the principles of the Republican Party in the last five years. A single exception to the above shall be approved for a voter renounces affiliation with any other party in writing, and who expresses in writing that he/she is in accord with the principles of the Republican Party and intends, at the time of the writing to support the nominees of the Republican Party in the future. A voter that utilizes the foregoing exception as identified in this paragraph thereafter participates in the nomination process of a party other than the Republican Party shall not have the benefit of this exception thereafter.

FILING REQUIREMENTS

Candidates for Unit Office:

Any person who desires to seek election as **Chairman, 1st Vice-Chairman, 2nd Vice-Chairman, Treasurer, Secretary or General Counsel (must be a lawyer)** for the Floyd County Republican Committee, must file or email a written notice to that effect. The written declaration must be received by 5:00 p.m. *Monday, March 18, 2024*, and Postmarks Do Not Govern. **Nominations shall be accepted from the floor at the mass meeting.** If, at the mass meeting only one legally-filed Candidate has applied for any office to be filled, that Candidate shall be deemed to have been elected to that office. Each Candidate may file for multiple offices, but elected to one office only. **All** Candidates will be elected by a plurality of votes. If no person files for an office, a Nominating Committee will act to fill that office.

Candidates for Convention Delegates:

Candidates for election as Delegates for 2024 State Convention at the RPV State Convention to be held on May 31 - June 1, 2024 at Hampton Roads Convention Center, 1610 Coliseum Dr. Hampton Va. 23666, or its alternate site, Convening at 2:30 p.m. on Friday, May 31 and 10 a.m. on Saturday June 1st may pre-file without attending the mass meeting. Pre-file Forms must be received by email, postal mail or in-person by 5:00 p.m., *Tuesday, March 19th, 2024*. Postmarks Do Not Govern. A mandatory registration fee of forty-five dollars (\$45.00) is requested for the state convention. Both the Pre-file Delegates and those who file at the mass meeting will be elected at the mass meeting.
