OFFICIAL CALL

Party Canvass of Frederick County Unit Committee of the Republican Party of Virginia

As Chairman of the Frederick County Unit Committee of the Republican Party, and pursuant to the Plan of Organization and as recommended and directed by the Committee, I, Ben Weber, do hereby issue this call for a Party Canvass to be held at Millwood Station Fire Company Banquet Hall, 252 Costello Dr., from 4 pm to 8 pm on Tuesday, March 26, 2024, for the following purposes:

- A) Electing a Unit Chairman.
- B) Electing members of the Unit Committee as follows (number per district):
 - Stonewall: 165 Red Bud: 160, Shawnee: 244, Opequon: 234, Back Creek: 333, Gainesboro:307
 - At-Large: 420
- C) Electing up to 1110 Delegates and an equal number of Alternates to the 6th Congressional District Convention, to be held May 11, 2024, starting at 10 a.m., at the Rockingham County Fairgrounds, 4808 S. Valley Pike, Harrisonburg, VA, for the purposes of:
 - Electing a Chairman for the Sixth Congressional District of the Republican Party of Virginia,
 - Electing three (3) Regional Vice Chairmen for the Sixth Congressional District of the Republican Party of Virginia
 - Electing three representatives to the State Central Committee of the Republican Party of Virginia,
 - Nominating an elector to vote for the Republican candidate for President, and
 - The transaction of such other business that may properly come before the Sixth Congressional District Republican Convention
- D) Electing Delegates to the 2024 Quadrennial Convention of the Republican Party of Virginia being held on May 31 – June 1

Qualifications for Participation

All legal and qualified voters of Frederick County under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions or primaries encompassing their respective election districts.

Filing Requirements

Candidates for election at said canvass shall file the requisite form(s) by mail, to: Frederick County Republican Committee, PO Box 1688, Winchester, VA 22604, or in person to Ben Weber, 241 Gravenstein Court, Winchester, VA 22602, which must be received not later than 6 pm, March 19, 2024. Postmarks are not valid.

There is no registration fee to participate in this canvass.

Filing Fees for candidates: (must be submitted with the filing form).

- \$150 for the office of Chairman
- \$35 for committee membership
- \$20 for 6th District delegate
- \$45 for delegate to the Quadrennial Convention

If not more than the number of persons to be elected shall file for each office, then such properly filed persons shall be declared nominated or elected as the case may be, and no canvass will be held for such purpose.
