Filing Requirements for Candidates

Candidates for the Republican nomination at said canvass shall file with the Legislative District Chair in person, to John C Atkinson, the following items.

- 1. 82nd House District Canvas Candidate Filing Form
- 2. A non-refundable Filing fee of Seven Hundred Five Dollars and sixty cents (\$705.60) made payable to the "Republican Party of Virginia Beach" (RPVB)

Any person who desires to seek the nomination as the Republican candidate for the 82nd House District, General Assembly of Virginia, must deliver the above items to the LDC on Friday May 21st 2021 between 12:00 p.m. and 5:00 p.m. at 932 Laskin Road, 3rd Floor, Virginia Beach, VA 23451. *If only one candidate properly files, then said candidate shall be declared the Republican nominee and no canvass will be held.*

Registration and Fee

There will be no pre-registration or fee for eligible voters to participate in this canvass.
