



OFFICIAL CALL

Mass Meeting of the Albemarle County Republican Committee of the Republican Party of Virginia

As Chairman of the Albemarle County Republican Committee, and pursuant to the Plan of Organization and as recommended and directed by the Committee, I, George M. Urban, do hereby issue this call for a Mass Meeting to be held in the Lane Auditorium, Albemarle County Office Building, 401 McIntire Road, Charlottesville, Virginia, 22902 (or an alternate site, if necessary, as determined by the Chairman), starting at **6:30 PM** local time (with registration opening at 5:30 PM) on Wednesday, **March 25, 2020**, for the following purposes:

(i) to elect a Chairman of the Committee; (ii) to elect Members of the Committee; (iii) to elect up to 680 Delegates (and up to 680 Alternates) to the Convention called by the Fifth Congressional District Committee of Republican Party of Virginia for April 25, 2020 (hereinafter the "District Convention"). The published District Convention call is hereby incorporated in its entirety into this call; and (iv) to elect up to 680 Delegates (and up to 680 Alternates) to the Convention called by the Republican Party of Virginia for May 1-2, 2020 (hereinafter the "RPV Convention"). The published RPV Convention call is hereby incorporated in its entirety into this call.

Qualifications for Participation

All legal and qualified voters of Albemarle County under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin, or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions, or primaries encompassing their respective election districts.

In addition to the foregoing, to be in accord with the principles of the Republican Party, unless otherwise stipulated by the appropriate Official Committee, a person otherwise qualified hereunder shall not have participated in Virginia in the nomination process of a party other than the Republican Party within the past five years. A single exception to the preceding shall be approved for a voter that renounces affiliation with any other party in writing, and who expresses in writing that s/he is in accord with the principles of the Republican Party and intends, at the time of the writing, to support the nominees of the Republican Party in the future.

Voters may be required to produce personal identification such as a valid driver's license or voter registration card in order to participate in the mass meeting. Only those individuals who are **registered (or are in line to be registered) by 6:30 PM** local time on Wednesday, March 25, 2020 will be entitled to participate in the Mass Meeting.

Pre-Filing Requirements for Committee Membership

Candidates to be Members of the Committee shall file an ACRC Membership Form (attached to this call), by mail to George Urban, 1236 Hatcher Court, Charlottesville, Virginia, 22903, by email to chairman@albemarlegop.org, or in person as provided in the following sentence. Membership forms may be filed in person only on Saturday, March 21, 2020, from 10:00 AM to 12:00 PM (Noon) local time to George Urban, 1236 Hatcher Court, Charlottesville, Virginia, 22903.

Membership forms must be received not later than **12:00 PM (Noon)** local time on Saturday, **March 21, 2020**. Postmarks do not govern and it is the responsibility of the candidate to confirm receipt.

Membership dues of **\$25** (or higher contribution) must be paid by March 31, 2020, in accordance with our bylaws. Checks should be made payable to “**ACRC**” and may be submitted with your membership form.

Failure to pre-file for membership shall not preclude election for membership at the mass meeting.

Pre-Filing Requirements for District Convention Delegates / Alternates

Candidates for Delegate or Alternate to the District Convention must file the official Delegate Form approved by the district committee (attached to this call), by mail to George Urban, 1236 Hatcher Court, Charlottesville, Virginia, 22903, by email to chairman@albemarlegop.org, or in person as provided in the following sentence. Delegate forms may be filed in person only on Saturday, March 21, 2020, from 10:00 AM to 12:00 PM (Noon) local time to George Urban, 1236 Hatcher Court, Charlottesville, Virginia, 22903. All Delegate Forms must be signed; email submissions must be a scan of a hard signed Delegate Form (e-signatures are not accepted).

Delegate Forms must be received not later than **12:00 PM (Noon)** local time on Saturday, **March 21, 2020**. Postmarks do not govern and it is the responsibility of the candidate to confirm receipt.

The district committee requests a **voluntary** delegate fee of **\$25** to help defray the costs of the convention. Checks should be made payable to “**ACRC**” and signed by the delegate candidate; ACRC will submit the total amount received to the district committee. You may include this fee with your Delegate Form or mail it separately to the address above if your form is submitted by email.

Pre-Filing Requirements for RPV Convention Delegates / Alternates

Candidates for Delegate or Alternate to the RPV Convention must file the RPV Filing Form (attached to this call), by mail to George Urban, 1236 Hatcher Court, Charlottesville, Virginia, 22903, by email to chairman@albemarlegop.org, or in person as provided in the following sentence. Filing forms may be filed in person only on Saturday, March 21, 2020, from 10:00 AM to 12:00 PM (Noon) local time to George Urban, 1236 Hatcher Court, Charlottesville, Virginia, 22903. All RPV Filing Forms must be signed; email submissions must be a scan of a hard signed RPV Filing Form (e-signatures are not accepted).

RPV Filing Forms must be received not later than **12:00 PM (Noon)** local time on Saturday, **March 21, 2020**. Postmarks do not govern and it is the responsibility of the candidate to confirm receipt.

RPV requests a **voluntary** Delegate Registration fee of **\$35** to help defray the costs of the convention. Note that any delegate who does not pay the fee may only participate in the Presidential Preference Poll at the convention. Checks should be made payable to “**RPV**” and signed by the delegate candidate. You may include this fee with your RPV Filing Form or mail it separately to the address above if your form is submitted by email.

Pre-Filing Requirements for Chairman

Candidates for Chairman of the Committee must file a written declaration by mail or in person, to George M. Urban, 1236 Hatcher Court, Charlottesville, Virginia, 22903, which must be received not later than **5:00 PM** on Friday, **March 13, 2020**. Postmarks will not govern and it is the responsibility of the candidate to confirm receipt. Nominations for Chairman from the floor will not be accepted unless no candidate for Chairman files by the deadline.

Registration Fees

There will be no registration fee to participate in this Mass Meeting.

Publication

This call will be published on the respective websites of the Albemarle County Republican Committee, the Fifth Congressional District Committee, and the Republican Party of Virginia. By a two-thirds vote of the committee, it will not be published elsewhere.
