OFFICIAL CALL

Party Canvass of the Alexandria City Members of the Republican Party of Virginia March 5, 2020 at 7:30pm

As Chairman of the Alexandria Republican City Committee, and pursuant to the Plan of Organization of the Republican Party of Virginia and as recommended and directed by the Committee, I, Sean Lenehan, do hereby issue this call for a Party Canvass to be held at the Minnie Howard School Main Auditorium, 3801 W Braddock Road, Alexandria Virginia 22302, starting at 7:30pm EST on March 5, 2020 for the following purposes:

- 1. Electing a Unit Chairman;
- Electing members of the Alexandria Republican City Committee, as follows: (List of Precincts and Number of Members for Precinct and Number of At-Large members) Ladrey-3; City Hall-4; Lyles Crouch-4; Durant Center-2; Lee Center-4; Cora Kelly-3; Mt Vernon-3; George Washington MS-3; Fire Dept-3; Charles Houston-2; Potomac Yard-1; Maury-3; George Mason-4; Agudas Achim-2; Blessed Sacrament-3; MacArthur ES-4; Chinquapin-3; Temple Beth El-4; NOVA Arts-3; James Polk-3; Hermitage-2; Patrick Henry ES-2; Beatley Library-2; Tucker School-3; John Adams ES-2; William Ramsey-2; South Port-3; Cameron Station-4, At Large-25.
- 3. Electing up to 240 Delegates and an equal number of Alternates to the District Convention of the 8th Congressional District, to be held on May 30, 2020 at the Waterford, 6715 Commerce Street, Springfield VA 22150, beginning at 8:00AM EDT for the purpose of:
- A. Electing a District Chairman;
- B. Nominating a Republican candidate for member of the U.S. House of Representatives to be voted for at the election on Tuesday, November 3, 2020;
- C. Nominating a Republican candidate for elector for President and Vice-President of the United States to be voted for at the election on Tuesday, November 3, 2020;
- D. Electing three members of the State Central Committee for a term of four years or until their successors are elected;
- E. Electing three delegates and three alternate delegates to the Republican National Convention to be held in Charlotte, North Carolina on August 24-27, 2020;
- F. and for the transaction of such other business as may properly come before the convention
 - Electing up to 485 Delegates and an equal number of Alternates to the State Convention, to be held on May 1-2, 2020 at the Greater Richmond Convention Center, 403 N 3rd St, Richmond, VA 23219, beginning at 2:30pm EDT May 1, 2020 for the purpose of:
- A. Binding Virginia Delegates to the 2020 Republican National Convention as to their choice for President on the first ballot by a Presidential Preference Poll;
- B. Electing 12 At-Large Delegates ("National Delegates") and 12 At-Large Alternate Delegates ("National Alternates") to the Republican National Convention to be held on August 24-27, 2020 at the Spectrum Center, Charlotte, NC in (or its alternate site) (the "National Convention");
- C. Nominating two Electors At-Large to be voted for in the presidential election on November 3, 2020;
- D. Electing a State Chairman;
- E. Nominating a National Committeeman and National Committeewoman;
- F. And for the transaction of such other business as may properly come before the Convention.

Qualifications for Participation

All legal and qualified voters of the City of Alexandria under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia participate in this Mass Meeting, subject to the provisions in Article I of the Plan of Organization.

There is no registration fee for participants.

Filing Requirements

Candidates for election as Unit Chair must file a written statement by February 17, 2020 at 5:00pm EST and shall include with their written statement a check or evidence of payment of a \$500 non-refundable filing fee. This will be submitted to the chairman of the rules and credentials committees, Bruce Brown at BABrown1951@gmail.com or 2707 Bryan Place, Alexandria VA 22302. The written statement and check or evidence of payment of the filing fee must be received by 5:00pm on February 17, 2020, and postmarks do not count.

Candidates for election to membership of the Alexandria Republican City Committee must file a written statement or membership application by March 1, 2020 at 7:30pm EST and shall include with their written statement a check or evidence of payment of \$100 filing fee. The filing fee can be paid online via credit card, bank draft or PayPal at AlexGOP.org/donate for the amount of \$100. The written statement or membership application can be submitted to ARCC, PO Box 245, Alexandria VA 22313.

There will be a single filing for precinct and at-large members. All precinct posts will be filled by order of filing and then any precinct overflow will be at-large members.

Military Members as Delegates

Military Members (any members of the Virginia National Guard, or the United States Armed Forces, Merchant Marine, or Coast Guard currently serving on active duty) who comply with these filing requirements shall not be required to be elected, but shall be declared delegates pursuant to Article VIII, Section H. of the Plan of Organization of the Republican Party of Virginia.

Military Member delegates or alternate delegates that are unable to attend the convention in person due to obligations of their official military orders, shall have their votes cast within their unit delegation according to candidate preference ballots. Instructions regarding the casting of candidate preference ballots are available in the Call for the Convention, which is available on the website of the Republican Party of Virginia at RPV.org

Cancellation

If not more than the number of persons to be nominated or elected shall file for any office, then such properly filed persons shall be declared nominated or elected as the case may be, and no election will occur for that office. Should all elections be cancelled, the Party Canvass will also be cancelled. A notice of cancellation will be posted on the website of the Republican Party of Virginia at RPV.org

Publication

This Call shall be posted on the website of the Republican Party of Virginia at RPV.org and the Alexandria Republican City Committee waived the newspaper publication requirement by at two-thirds vote. Paid for and authorized by the Alexandria Republican City Committee
