People wishing to renounce their affiliations with other parties MUST complete a written renunciation, which will be subject to public scrutiny at the Mass Meeting. In accordance with the State Party Plan, Mass Meeting Members may choose to elect or reject any person seeking election to the Committee. Written renunciations will become part of the permanent public records of the Republican Party, regardless of the Mass Meeting Members' election or rejection of the person making the renunciation. A second violation of the above oath is a lifetime disqualification from participation in Republican Party functions.
