C. Electing Delegates and Alternates to the 5<sup>th</sup> District Republican Party Convention to be held April 25, 2020 at the Tree of Life Ministries 2812 Greenview Drive, Lynchburg, VA 24502

D. And for the transaction of such other business as may properly come before the Mass Meeting.

E. Guest Speakers from any 2020 candidates seeking office. Only 2020 Candidates will be permitted to speak

All legal and qualified voters of Brunswick County under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions or primaries encompassing their respective election districts.

## State and 5th District Convention Delegate Filing Requirements

Delegate candidates for election at said Mass Meeting shall file, two separate applications for each Convention, Deadline for delegate forms to be turned in to Eric Brazeal, current chairman, no later than 5pm Saturday March 21, 2020. Post marks do not govern. Scan and email copies will be permitted.

### **Brunswick County Republican Committee Unit Officers**

Candidates for election local County Republican Committee officers will be required to file in writing their intent to seek election as county chairman no later then March 21, 2020. All inquires must be turned in to Eric Brazeal, current chairman, no later than 5:00pm Saturday March 21, 2020. Post Marks do not govern. Scan and email copies will be permitted.

### **Registration Fees**

The Republican Party of Virginia is requesting a voluntary \$35 filing fee from all individuals seeking election as a Delegate to the State Convention. Checks need to be made out to the "Republican Party of Virginia". If the voluntary fee is not paid then President of the United States is the only position you will be permitted to vote for at the state convention.

The Republican Committee of the 5th Congressional District is requesting a voluntary \$25 filing fee from all individuals seeking election as a Delegate to the 5th Congressional District Convention. Checks need to be made out to the "Brunswick County Republican Committee".

Filing Fee of \$20 must be paid to run for election of Chairman of Brunswick County Republican Committee. Checks must be written to the "Brunswick County Republican Committee"

### **Cancelation Disclaimer**

The Mass Meeting of Brunswick County Republican Committee is subject to cancelation if less than the maximum number of delegates (100) is turned in, and only one person files to be chairman.
