Registration shall start at 6:00pm and the meeting shall come to order at 7:00pm local time, or later if registration has not been completed, on Thursday, March 5, 2020 for the following purposes:

1. Electing a Chairman of the Charlotte County Republican Committee

2. Electing all Officers of the Charlotte County Republican Committee (Vice-Chairman, Secretary, and Treasurer)

3. Electing members of the Unit Committee

4. Electing up to 120 Delegates and an equal number of Alternates to the District Convention of the

5th Congressional District, to be held on Saturday, April 25, 2020 at Tree of Life Ministries, 2812

Greenview Drive, Lynchburg, VA 24502, or its alternate site, beginning at 10:00am for the purpose of:

a) Election of 3 National Delegates for the 2020 Republican National Convention

- b) Election of 3 Alternate National Delegates for the 2020 Republican National Convention
- c) Election of 3 State Central Committee Members
- d) Election of 1 Elector for the 2020 Presidential Election
- e) Election of District Committee Chairman
- f) Election of Republican Nominee for U.S. House

g) Transaction of such other business as may properly come before the Convention

5. Electing up to 120 Delegates and an equal number of Alternates to the Republican Party of Virginia State Convention, to be held on May 1-2, 2020 at the Greater Richmond Convention Center, 403 North 3rd Street, Richmond, VA 23219, or its alternate site, convening on 5/1 at 2:30 pm and on 5/2 at 10:00 am, for the purpose of:

a) Binding Virginia Delegates to the 2020 Republican National Convention as to their choice for President on the first ballot by a Presidential Preference Poll;

b) Electing 12 At-Large Delegates ("National Delegates") and 12 At-Large Alternate Delegates

("National Alternates") to the Republican National Convention to be held on August 24-27,

2020 at the Spectrum Center, Charlotte, NC, or its alternate site (the "National

Convention")

c) Nominating two Electors At-Large to be voted for in the presidential election on November 3,

2020

d) Electing a State Chairman

e) Nominating a National Committeeman and National Committeewoman

f) And for the transaction of such other business as may properly come before the Convention

6. Transaction of such other business as may properly come before the mass meeting.

Qualifications for Participation

All legal and qualified voters of Charlotte County under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions, or primaries encompassing their respective election districts.

Filing Requirements

Candidates for election as Chairman at said mass meeting may file a written statement - which must include your full legal name, address, and voting precinct so that a candidate's qualification to serve as Chairman can be determined - by mail or in person, to Peggy Armentrout, Chairman, 1645 George Washington Hwy, Charlotte Courthouse, VA 23923, which must be received not later than 5:00pm on February 27, 2020. Statements that do no not contain all information listed above shall be rejected. Postmarks do not govern, and it is the responsibility of the candidate to confirm receipt of their statement of candidacy with the Chairman. Emailed statements shall not be accepted.

Individuals who wish to be elected Delegates to either the 5th Congressional District Convention or the Republican Party of Virginia State Convention shall file the appropriate delegate pre-file forms by postal mail, email, or in person which includes your full name, mailing address, and phone number to Peggy Armentrout, Chairman, 1645 George Washington Hwy, Charlotte Courthouse, VA 23923, or pegsfarm2@hotmail.com, which must be received not later than 7:00pm on March 5, 2020.
