Party Canvass of the Chesapeake City Committee Members of the Republican Party of Virginia

As Chairman of the Chesapeake City Committee of the Republican Party of Virginia, and pursuant to the Plan of Organization of the Republican Party of Virginia and as recommended and directed by the Committee, I, Nicholas D. Proffitt, do hereby issue this call for a Party Canvass to be held at a location to be determined by the Chairman no later than March 31, 2021, or its alternate site, starting at 4:00 PM and finishing at 8:00 PM local time on Thursday, April 22, 2021 for the following purposes:

- A. Electing up to 1825 Delegates and an equal number of Alternates to the Virginia State Republican Convention, to be held on Saturday, May 8, 2021, beginning at 9:00 AM, for the purpose of
 1. Nominating one (1) Republican candidate each for the offices of Governor, Lieutenant Governor, and Attorney General in the November 2, 2021, General Election;
 2. And for the transaction of such other business as may properly come before the Convention.

Qualifications for Participation

All legal and qualified voters of the City of Chesapeake under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees and endorsees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in this Party Canvass, subject to the provisions in Article I of the Plan of Organization.

Registration:

Party Canvass participants must present one of the forms of photo-identification listed in § 24.2-643 of the Code of Virginia in order to participate. There will be no fee to participate.

Filing Requirements

Candidates for election at this Party Canvass should complete and obtain an official filing form, which is available on the RPV website at www.virginia.gop and on the RPC website at www.ChesapeakeGOP.org. To be considered for election at said Party Canvass, the signed filing form must be returned to Nicholas Proffitt, by e-mail at nproffitt712@gmail.com or by physical or mail delivery at 1001 Copper Stone Circle Chesapeake, Virginia 23320, which must be received not later than 9:00 PM on Monday, April 19, 2021. Postmarks shall not govern.

Cancellation

In the event the number of candidates properly filed does not exceed the number of Delegates to be elected, those candidates shall be deemed elected and the Party Canvass cancelled. A notice of cancellation will be posted on the RPC website at www.ChesapeakeGOP.org.

Publication

This Call shall be posted on the RPC website at www.ChesapeakeGOP.org/event-calendar. The Chesapeake City Committee waived the newspaper publication requirement by a two-thirds vote.
