PUBLIC NOTICE

Pursuant to The Plan of Organization (the "Party Plan") of the Republican Party of Virginia (RPV), the Bylaws (the "Bylaws") of the Fauquier County Republican Committee (the "County Committee"), and in accordance with the rules adopted by the County Committee on the 3rd day of March, 2020, in conformity with the Party Plan and the Bylaws, I, **Gregory Schumacher**, Chairman of the County Committee, do hereby issue this **Official Call for a Republican Party Canvass** to be conducted in the County of Fauquier on **Saturday the 4th day of April, 2020**.

The purposes of this canvass are as follows:

- 1. Electing up to 730 Delegates and an equal number of Alternates to the Republican Party of Virginia State Convention, to be held on May 1-2, 2020 at the Greater Richmond Convention Center or its alternate location, beginning at 2:30 pm for the following purposes: a) Binding Virginia Delegates to the 2020 Republican National Convention as to their choice for President on the first ballot by a Presidential Preference Poll, b) Electing twelve (12) At-Large Delegates ("National Delegates") and twelve (12) At-Large Alternate Delegates ("National Alternates") to the Republican National Convention to be held on August 24-27, 2020, at the Spectrum Center, Charlotte, North Carolina (or its alternate site) (the "National Convention"), c) Nominating two (2) Electors At-Large to be voted for in the presidential election on November 3, 2020, d) Electing a State Chairman, e) Electing a National Committeeman and National Committeewoman, and for f) The transaction of such other business as may properly come before the Convention:
- 2. Electing up to 155 Delegates and an equal number of Alternates to the First Congressional District Convention to be held on June 13, 2020 at Caroline County High School, Milford, Virginia, with registration beginning at 10:30 am and the convention beginning at 1:00 pm for the following purposes: a) Electing a Chairman for the First Congressional District of the Republican Party of Virginia, b) Electing three (3) members of the Republican Party of Virginia State Central Committee, c) Electing three (3) Delegates ("National Delegates") and three (3) Alternate Delegates ("National Alternates") to the Republican National Convention to be held on August 24-27, in Charlotte, North Carolina, d) Electing one (1) Presidential Elector to be voted for in the Presidential Election on November 3, 2020, and for e) Transacting such other business as may properly come before the convention;
- 3. Electing up to 575 Delegates and an equal number of Alternates to the Fifth Congressional District Convention to be held on April 25, 2020 at the Tree of Life Ministries, Lynchburg, Virginia or its alternative site, with registration beginning at 8:30 am and the convention beginning at 10:00 am for the following purposes: a) Electing three (3) National Delegates to the Republican National Convention, b) electing three (3) National Alternates, c) Electing one (1) Presidential Elector for the Presidential Election, d) Electing three (3) State Central Committee members, e) Electing a Chairman for the Fifth Congressional District, f) Electing the Candidate for the 2020 Fifth Congressional District election, and for g) The transaction of such other business as may properly come before the Convention; and
- 4. The election of 157 Precinct members, 47 At-Large members, and a Chairman of the Fauquier County Republican Unit Committee.

All legal and qualified voters of Fauquier County, Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who express in writing their intent to support all of its nominees for public office in the ensuing election, may participate as a members of the Republican Party of Virginia in this Canvass. A person who has made application for registration as a voter in Fauquier County and meets the requirements set forth above, but whose name does not appear on the local registration books solely because the books

having been closed in connection with the local election, will nevertheless be deemed a legal and qualified voter.

Pre-filing requirements:

Any candidate for Delegate to the RPV State Convention shall file with the County Committee a declaration of candidacy and petition in the same form as set forth herein together with an optional registration fee of \$35.00 for the RPV State Convention, which, if submitted, helps defray the costs associated with the Convention and is thus non-refundable. Any delegate who fails to pay the registration fee may participate only in the Presidential Preference Poll.

Any candidate for Delegate to the First Congressional District Convention shall file with the County Committee a declaration of candidacy and petition in the same form as set forth herein together with an optional registration fee of \$5.00 for the District Convention which, if submitted, helps defray the cost associated with the Convention and is thus non-refundable.

Any candidate for Delegate to the Fifth Congressional District Convention shall file with the County Committee a declaration of candidacy and petition in the same form as set forth herein together with an optional registration fee of \$25.00 for the District Convention which, if submitted, helps defray the cost associated with the Convention and is thus non-refundable.

Any candidate for Chairman of the County Committee shall file with the County Committee a declaration of candidacy in the same form as set forth herein together with a mandatory fee in the amount of \$250.00.

Any candidate for an At-Large Seat on the County Committee shall file with the County Committee as declaration of candidacy in the same form as set forth herein together with a mandatory fee in the amount of \$45.00. There are 47 At-Large seats.

Any candidate for a Precinct Member seat on the County Committee shall file with the County Committee a declaration of candidacy in the same form as set forth herein together with mandatory fee of \$35.00. Precinct seats: Airlie (8), Baldwin Ridge (5), Bealeton (10), Broad Run (8), Casanova (4), Catlett (12), Courthouse (9), Kettle Run (5), Leeds (7), Lois (5), Marshall (9), Morrisville (8), New Baltimore (9), Opal (5), Remington (9), Springs Valley (5), The Plains (6), Vint Hill (14), Warrenton (8), and Waterloo (11).

A candidate may file for only one position on the County Committee. All filings for all positions, together with all applicable fees must be received, in the forms set forth herein, no earlier than the publication date of this call and no later than 5:00 pm, March 20, 2020 by 5:00 pm (the "Prefiling Deadline"). Postmarks shall not govern.

Election:

This election shall be held at The Fauquier High School, 705 Waterloo Road, Warrenton, VA 20186 or its alternate site on the 4th day of April 2020 from 8:00 am to 4:00 pm. In the event the number of prefiling candidates does not exceed the number of nominations for that particular office, then the properly pre-filed candidate or candidates shall be deemed automatically elected as of the date of the Prefiling Deadline. If the number of persons pre-filing as candidates in the County Committee Canvass does not exceed the number of nominations for that particular office, then the pre-filed candidate or candidates may be declared the winner of the office. If candidates for nomination for all

offices to be decided upon in the County Committee Canvass are unopposed, then the candidates may be declared the winners and this Canvass will be cancelled. *See RPV Party Plan, Article VIII, Section A, Paragraph 9.*

Qualification of Candidates:

All candidates shall be legally qualified voters of the County of Fauquier at the time of the pre-filing deadline and shall make written declaration they are in accord with the principles of the Republican Party and that they intend to support all of its nominees in the ensuing election. Any candidate for Committee Membership who fails to properly indicate their precinct on the filing form shall be disqualified for that reason alone.

Time and place of filing:

All filings for all positions, together with all applicable fees, shall be filed with the Fauquier County Republican Committee, P.O. Box 925, Warrenton, Virginia 20188-0925. All filings along with all applicable fees, in the forms set forth herein, must be received no earlier than the publication date of this Official Call and no later than the Prefiling Deadline of 5:00 pm, March 20, 2020. Postmarks do not control. All declarations not complying with the requirement of this Notice and Rules of Canvass will be disqualified.
